- Payment will be made after successful completion of work, and it may take at least 1
 month time to complete the process of Payment subject to fulfillment of entire
 document related criteria required by the Account/ Audit department of SMC.
- Firm who have not registered party code in SMC, may also apply for the said work
 subjected they have to generate the party code of the payment purpose by
 submitting required documents.
- 10. 02% SD (Security Deposit) of total contract value shall be submitted in form of DD b contractor within 15 days after awarding the contract. Failure to this tends to SD delay penals
- 11. Quotations received after due date will not be considered.
