**TERMS AND CONDITIONS :-**

1. The agency must visit the site before quoting the Rates.
2. Quotation once offered shall not be withdrawn by Vendor.
3. Quotation once accepted shall be binding to the Vendor/Contractor.
4. The rates quoted must include all taxes, duties/ levies, GST, (Goods and Service Taxes) freight, insurance, transportation, delivery and Loading unloading at the site etc Complete.
5. The decision of i/c Deputy Commissioner, c/o Public Infrastructure Cell, SMC shall be final in respect of disputes what so ever arise.
6. Right to accept any or to reject any or all the offers without assigning any reason thereof is reserved by the competent authority of Surat Municipal Corporation. Surat.
7. Accordingly, the contractor shall have to quote and submit within stipulated time limit.
8. All necessary safety measures and precautions (including those laid down in the various relevant Indian Standards) shall be taken to ensure the safety of men, materials and machinery on the works as also of the work itself.
9. Overall lowest bidder shall be taken for consideration.

10. Conditional offer shall not be accepted.
11. Defect liability period for the above entire work shall be of one (1) year.
12. The contract shall be constituted according to and subject to laws in India and state of Gujarat and under the jurisdiction of courts of Gujarat at Surat City only.
13. Tenderer to whom the award is made shall furnish a performance guarantee (initial Security Deposit) for amount equal to Two percent (2%) of the contract price by a demand draft of a Scheduled nationalized bank Acceptable to owner on the Surat Branch. Security deposit shall be paid in time and if it is paid after Ten (10) days from the date of work order then the penalty of 0.065 % per day of the amount of security deposit shall be recovered from the contractor the performance guarantee (security deposit) will be returned to the contractor after the defect liability period (one year after completion of work) and on completion of audit related procedure.
14. The successful contractor shall have to bind in an agreement with SMC for the stated work.
15. All the payments shall be made as per prevailing rules of SMC.
16. Time limit of the work is 15 days from the issuing date of the work order. If the contractor fails to complete the work within the stipulated completion date for the work or he shall pay liquidated damages 0.2% of contract value per day of delay in completion or part thereof as the case may however, be subjected to a maximum of ten (10) percent of the uncompleted work.
17. **The sealed cover containing the offer shall reach to "Chief Accountant, Accounts Department, Surat Municipal Corporation, Muglisara, Surat" on or before 14.06.2023, 18.00 Hrs. The offer shall be submitted to Govt. Regt. A.D. or Speed Post only.**
