Terms/conditions of quotation

*	Work Completion Period of entire work	2 year from the date of work order or Mention in Workorder
*	All Taxes/Duties,GST, Octroi etc.: -	The rate should be Excluding of GST and including of all other taxes, duties, labor charges and transportation, loading unloading, watch and ward etc. at Site.
*	FOR: -	AMC of UPS syatem located at various Muni. Buildings in South Zone-A(Udhna), SMC Surat.
*	Validity of quotation: -	120 Days from the last date of submission.
*	Payment condition: -	Payment shall be made monthly basis after submission of required document mention elsewhere & invoice.
*	Make	For Battery @ Exide, Amron, Luminious

- The work is to be carried out in the premises of SMC only. In case the work can not be done in the premises of SMC, contractor can take away unit for repair, no extra charge will be payable on this account. Standby UPS(s) must be put into service till the time repaired unit is installed & make operational on its original position. No extra charge will be pay for standby arrangement.
- Representative of the firm shall not remove any part(s) or whole from the equipment's without permission of the representative of SMC.
- The firm shall have to attend all complaints on receipt of information from the users directly with the prior approval of light department of south zone-A. The services should be provided on regular basis during office hours. In case of emergency contractor must provide service beyond office hours & on holyday as well.
- The rates quoted shall remain in force for full period of contract.
- The owner of the firm should be available on his landline telephone and also on mobile phone.
- The term "Annual Maintenance" include maintenance of all parts of UPS, including supply of original spares except batteries. The bidders should indicate the cost of batteries in Annexure B. Battery must have 6 month warranty.
- The firm will have to repair the equipment within 24 hours from receipt of complaint. if not, the SMC will get it repaired from other contractor and the expenditure so incurred on such repairs including administrative charges will be deducted from the AMC payment, due for payment to contarctor.
- Annexure-A shows existing number of UPS installed at various location of South zone of SMC. It may vary during the contract period. For such alteration, SMC will intimate contractor to strat annual maintenance of those UPS. Payment shall be made on the basis of actual numbers of UPS are maintained during that period.
- The contractor will have to repair the equipment within 24 hours from receipt of complaint, failing which penalty at a rate of Rs.200 per day per unit of delay shall be charged. In case of the unit remains unrepaired on any account for a period exceeding 7 days, the penalty at a rate of Rs.500 per day per unit shall be charged.
- Successfull Contractor have to do Agreement, Surety & Undertaking on the non judicial stamp paper of Rs.300/- each purchased from Surat city only.
- The firm must have an office or workshop in Surat.
- The period of Annual Maintenance Contract for maintenance/repair of UPS will be two (2) year from the date of the award of the contract.
- SMC will not pay any transportation charges and also not provide any type of assistance whice carrying out above mention work. All accessories needed in AMC work of above mentioned items are in contractor's scope only. Contractor must replace faulty spare with genuine spare only.
- The rate should be **Excluding of GST** and including of all other taxes. Fulfillments of this condition are must or else the quotation shall be liable for outright rejection.
- The name of work i.e.“ Quotation for the work of” must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.
