The above work of supply has to be completed within 15 days from the date of work order/ LOI otherwise penalty @ 0.2% of amount unexecuted work per day for delayed work should be recovered from your bill or otherwise. The amount of maximum delay penalty shall be equal to 10% of unexecuted amount of work order.
5. No payment shall be made in advance. 85% payment shall be released after supply of materials/ instrument satisfactorily. Remaining 15% payment shall be released after observation of functioning of the various instruments for 1 month and found the same satisfactory.
6. Payment shall be made as per prevailing practices/ processes/ circulars related to payments in SMC.
7. The offer shall be submitted in a sealed cover to "Executive Engineer, Central Zone, Surat Municipal Corporation, New Admin Building, Mugalsarai, Surat - 395 003".
8. SMC reserves its right to accept or reject any orall quotation without giving any reason.
9. Corporation will not issue any 'C' or 'D' form.
10. **Contractor/ supplier have to submit the technical catalogues for the various instruments/ items offered by them.
