- 2. **Time Limit for whole work will be 120 Days From the Date of Work Order.** In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay. That will be maximum up to 10% of tender amount.
- 3. Successful agency shall have to enter in to Agreement as well as Surety & Undertaking to be submitted on suitable Gujarat State stamp paper.
- 4. The quoted rate should be inclusive of all taxes, duties, GST and labour charges and transportation etc.
