TERMS AND CONDITIONS :-

1. Additional City Engineer, SMC shall be final authority for decision in case of any dispute.
2. The bidder must attach GST registration certificate, PAN Card etc.
3. Cover shall mention on top name of work, name of agency and duly sealed and send this cover in time limit mentioned above to South west (Athwa) Zone near Adars Bhavan, Athwalines, Surat-395001.
4. When there is necessary of SMC , required numbers of fitting should must be supply by bidders.
- 5 **Time Limit for the work will be 30 Days.** In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that wil be maximum up to 10% of delayed work.
- 6 The work must be completed in all respect within stipulated time period as mentioned in Important instruction to bidder, failing which penalty @ 0.2% of order value of unexecuted portion per day of delay subject to maximum 10% of order value shall be charged and shall be deducted from the bill or any outstanding payment. Also, if contractor fails to execute the work than action against contractor will be taken as per decision of competent authority of SMC and that should bind to contractor.
7. Successful agency shall have to submit 2 % of quoted Amount as a security deposit & also enter in to Agreement, Surety & Undertaking on Rs.300 suitable Gujarat State stamp paper each.

8. The rate should be inclusive of all taxes including GST, duties, and Labour charges and transportation etc.
9. The offer shall remain valid up to 120 days from the date of receipt any or all the Quotation .
10. SMC Reserves its right to accept or reject any quotation without giving any reason.
11. The offer must be in the format attach herewith only otherwise offered will be rejected.
12. Payment shall be made within at least 30 days from the completion of work and producing retail invoice.
13. The offer shall be submitted with Earnest Money Deposit Rs. 2000/- in the form of Demand Draft or Pay Order or Banker's Cheque in favor of SURAT MUNICIPAL CORPORATION, payable at surat. Offer without EMD shall not be considered.
14. Entire System shall have to be certified by Chief Fire officer of Surat Municipal Corporation and necessary NOC shall have to be obtained.
15. All material Testing reports shall have to be submitted.
