1. The rate should be excluding GST and including all taxes, duties, labor charges and transportation, loading unloading, manpower & machinery/equipments.
2. Work shall be carried out as per instruction of Engineer in charge and as per site requirement.
3. Time limit for the work starts 10(Ten) days after the work order date. Failing which penalty @ 0.2% of order value of unexecuted portion per day of delay subject to maximum 10% of unexecuted portion order value shall be charged and shall be deducted from the Security Deposit.
4. 100% Payment shall deposited by contractor in advance. CGST & SGST shall be deposited by contractor in advance as per prevailing rate time to time.
