SCOPE OF WORK

- Spare parts used for repairs shall be original genuine and of good quality and/or same/equivalent as defective/damage material to be replaced. No second hand material will be tolerated for replacement purpose.
- SMC shall not provide any transportation fare or other charges if a question arises of transfer of any machine under contract outside the campus for repair.
- The maintenance & repairing work shall be carried out by certified technicians only.
- Technicians employed for the said work shall be provided with personal safety equipments / accessories.
- All the acts rules and regulation applicable for such type of work shall be followed by contractor.
- It shall be contractor responsibility to get acquainted with type of acts rules, regulations, and general rules, applicable to this type of work.
- The contractor shall quote the rate in "price schedule" only.
- All tools, tackles, labour and material including consumable etc required will be in scope of contractor.
- This work is comprehensive in nature and includes all type of minor/major tools, tackles, and man power.
- The contractor shall be responsible for safety on site during the works. All the necessary personal protective safety equipments, material for the staff shall be bought by the contractor
- · Additional City Engineer, SMC shall be final authority for decision in case of any dispute.
- The bidder must attach GST registration certificate, PAN Card etc.

> TIME LIMIT / WORK COMPLETION PERIOD

• Time limit considered for the entire job will be 1 month after 10 days of the work order issued.

Experience Required: -

The contractor shall have an active experience in similar works.

PRICES AND PAYMENTS: -

• The tenderer must understand clearly that the prices quoted are for the total works i.e. repairing of high quality professional sound system and include all costs due to spare parts, material, labour, supervisions, transportation, loading unloading watch and ward etc. mentioned in scope of work.

> SECURITY DEPOSIT/AGREEMETHT/STAMP DUTY:

- Successful Contractor shall be required to deposit an amount equal to 2% of total order value as Security Deposit in Cash/ by Demand Draft within 10 (Ten) days from per day of delay shall be charged.
- Successful bidder have to entering into contract agreement and furnishing undertaking to SMC supported by surety from local reputed contractor to be given on suitable Indian Non Judicial stamp paper worth Rs. 300 each purchased from Surat. However, the stamp duty at prevailing rate shall be applicable if revised by Government.

> TERMS OF PAYMENTS: -

- Payment shall be made as per actual work done on site.
- Quotation once offered shall not be withdrawn, except with the permission of the competent authority.
- Quotation once accepted shall be binding to the contractor.
- Rate must be filled in this quotation paper only and returned duly sealed & signed otherwise offer will be rejected. No escalation in price during the contract period shall be allowed.
- The bidder must attach GST registration certificate, PAN Card etc.
- The rates for supply of equipments related to this sound system to be mentioned in Annexure A & repairing of equipments of this sound system to be mentioned in Annexure B should be with replacement of faulty spares & inclusive of all duties, GST & any other govt. levies if any.
- The offer must be in this format only otherwise offer will be rejected.
- The decision of Add. City Engineer shall be final in respect of disputes what so ever arise. Corporation reserve the right to accept or reject any or all the quotation without assigning any reason therefore.
- In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
- The offer shall remain valid up to 120 days from the date of receipt of the quotation.
- The name of work i.e. "Quotation for the work of....... "must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.
- Any dispute will be subject to the court, falling under Surat jurisdiction.
- Contractor shall be responsible to the accident/injury/Loss to any of the staff members of them. No compensation of any kind shall be paid by the corporation. The contractor shall observe latest Government rules regarding labour etc.
