- Successful Bidder shall have to furnish a performance guarantee (Initial S.D. Deposit) for amount equal to 2.5% of the contract amount by a demand draft of a Scheduled Nationalized Bank acceptable to owner on the Surat Branch. Security Deposit shall be paid in time and if it is paid after Ten (10) days from the date of work order, then the penalty of 0.065 % per day of

the amount of Security Deposit shall be recovered from the contractor. The performance guarantee (Security Deposit) will be returned to the contractor after the defect liability period (Six month) after completion of work) and on completion of audit related procedure.

2. **Time Limit for whole work will be 10 Days.** In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
3. Successful agency shall have to enter in to Rs. 300 Agreement & Undertaking on suitable Gujarat State stamp paper.
4. The rate should be inclusive of all taxes, duties, GST and labor charges and transportation etc.
