Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/ Bidder, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Bidder in this regard. Further, the non-payment of GST to the government may lead to the termination of contract. If imposition of any other new taxes/ Duties/ Levies/ Cess or any other incidentals etc. or any increase in the existing taxes/ Duties/ Levies/ Cess or any other incidentals etc. (Excluding GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Biderer only; in no case SMC shall be liable for the same.

The above work of supply has to be completed within 15 days from the date of work order/ LOI otherwise penalty @ 0.2% of amount unexecuted work per day for delayed work should be recovered from your bill or otherwise. The amount of maximum delay penalty shall be equal to 10% of unexecuted amount of work order.
- 5. No payment shall be made in advance. 100% payment shall be released after supply of 32 inch LED Display Screen satisfactorily.
- 6. Payment shall be made as per prevailing practices/ processes/ circulars related to payments in SMC.
