- Sealed Covers shall be sent to: The Executive Engineer, North Zone(Katargam) Office, Beside Ramjikrupa Raw House, Near Gajera school, Katargam. Surat-395004.

- 4 Quotation once accepted shall be binding to the contractor.
- 5 Conditional Quotations are straight away subject to rejection.
- 6 All duties/taxes/ GST levied by S.M.C. and Govt. shall be payable by the contractor.
- 7 The rate quoted by the agency should be inclusive of all taxes, Service charges and GST.
- 8 The decision of Competent Authority of SMC shall be final in respect of disputes what so ever arise.
- 9 It is mandatory ti submit **E.M.D. of Rs. 5,000/-** with Quotation in form of Demant Draft. Failing to this will result in rejection of quotation / bid.
- Multiplication of Rates with Quantity shall have precedence over the amount in case of ambiguity.
- Successful tenderer has to execute Agreement incl. Surety and Undertaking on the Stamp Paper of Rs. 300/- within 10 Days of issuing Work Order.
