Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/ Bidder, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Bidder in this regard. Further, the non-payment of GST to the government may lead to the termination of contract.</p> <p>If imposition of any other new taxes/ Duties/ levies/ Cess or any other incidentals etc. or any increase in the existing taxes/ Duties/ Levies/ Cess or any other incidentals etc. (Excluding GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Bidder only; in no case SMC shall be liable for the same.</p>

- Rates should be filled in this quotation paper only and returned duly sealed & signed by vendor.
- Contractor shall have to carry out repairing work as per the terms & condition.
- Bidder must have to offer Six Month warranty period for rewinding/repairing of Fan. Durings these 6 months if winding/repairing is failed, than contractor has to Rewind or repairs fan free of cost. Vendor list replacement of bearing shall be SKF, FAG, RHP, ABC.
- The Time Limit for fan repairing work shall be 07 days from date of intimation by SMC. After 07 days Rs.10 Will is charged for each Fan/day delayed as penalty, maximum up to 10% of contract value.
- Contractor shall have to take fan under repairing from the office and deliver required fan shall be back to the same office.
- The successful Contractor shall also be required to enter into contract agreement along with undertaking and local surety on Gujarat Stamp Paper purchased from Surat worth Rs. 300.00 for each (To be brought by the successful contractor).

- The successful Contractor shall be required to deposit an amount equal to 2% of the total order value as Security Deposit in Municipal Treasury in Cash/by Demand within 10 days from the date of work order otherwise; penalty @0.065% of the amount of security deposit per day of delay shall be levied.
- The firm must have workshop in Surat.
- SMC will not pay any transportation charges, loading/unloading etc. Bidder must quote rate considering the same. Contractor must replace faulty spare with genuine spare only. Sub Standard spares won't be allowed. If it observed that sub standard spares have been used, Spare will be replaced with genuine spare and cost of replacement with administrative charges will be deducted from contractor bill due for payment. Old Parts/damage parts, scrape material, etc. shall be credited to contractor, need not to submit/deposit back to SMC.
- The rate quoted shall remain firm for entire period of contract, No deviation in rate shall be allowed during contract period.
- The contract shall be terminated at any time in case of any failure to comply terms & condition of this quotation.
- Payment shall be made as per prevailing rules & regulation of SMC related to payments in SMC.
- Each Quotation must be accompanied by a receipt of deposit as Earnest money deposit of the amount mentioned in Table, in the form of crossed Demand Draft/Pay Order of Nationalized/Scheduled Bank acceptable to Corporation drawn in favour of the "Municipal Commissioner, Surat Municipal Corporation" payable at Surat. The earnest money deposit will be refunded after the award of work to successful contractor and successful contractor deposit security deposit to SMC.
- The offer shall be submitted in a sealed cover to "Executive Engineer, Central Zone, Surat Municipal Corporation, New Admin Building, Mugalsarai, Surat - 395 003".
- Corporation will not issue any 'C' or 'D' form.
- Calculation of applicable GST, TDS deduction etc. shall be done as per prevailing GST act/rules/regulation.
- Contractor shall have to maintain maintenance register for Fan Rewinding with SR. NO. of Fan.
- **The name of work i.e. "Repairing work of various type fans installed at various building of Central Zone, SMC for two years." must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.**
