#### Terms and Conditions :-

1. The rate should be inclusive of GST and all taxes, duties, labor charges and transportation, loading unloading, watch and ward etc.
2. Work shall be carried out as per instruction of Engineer in charge and as per site requirement.
3. Time limit for the work should be 10 days. Failing which penalty @ 0.2% of order value of unexecuted portion per day of delay subject to maximum 10% of unexecuted portion order value shall be charged and shall be deducted from the bill.
4. Payment shall be done accordingly to actual work carried out at site.
5. 100% amount of will be released after completion of work and submission of Invoice.
6. Successful Bidder has to deposit 2.5% of Tender Amount as a security deposit(SD) within 10 days of work order issued. Failing which 0.065 % of SD Amount per day has been charged as a delay penalty. Security deposit(SD) shall be released after completion of defect liability period(DFL).

7. Defect liability period shall be one year after completion of the work.
8. The successful Contractor shall also be required to enter into contract agreement on Gujarat Stamp Paper purchased from Surat worth Rs. 300.00.
9. Corporation will not issue any 'C' or 'D' form.
10. The offer shall remain valid up to 120 days from the date of receipt of the quotation.
11. Corporation reserves the right to accept or reject any or all the quotations without assigning any reason thereof.
12. The offer must be in the mention format only.

**Scope of work:-**

1. SETC OF (1) Water cooler having storage capacity 80 Ltr. & cooling capacity 40 Ltr. per hour and Water purifier UF-80 with pump & auto cut system at Velanja Urban Health Center and (2) Water purifier UF-80 with pump & auto cut system at Velanja Ward Office/ V.B.D.C. New East (Sarhana)Zone
2. Contractor shall have to visit all locations before quote the price. This work inclusive of buy-back offer of Existing Water cooler.
3. All tools, tackles, labour and material including consumables, etc required will be in scope of contractor.
4. All Plumbing work like Drain pipe and other piping works etc. required for execution of this work shall be in the scope of contractor. No extra payment shall be made to contractor for this.
5. Contractor shall have to provide one year guarantee for all the products offered. Guarantee period shall be started after completion of testing, commissioning and handing over the system to SMC.
6. All types of transportation inside and outside of SMC premise shall be carried out by contractor without any extra cost.
7. Contractor shall comply with all safety rules and regulations and all inter disciplinary measure as followed by the Corporation. All the necessary safety equipments, materials shall be brought by the contractor.
8. During defect liability period (12 months from the date of satisfactory commissioning & till the handing over to O & M Contractor), contractor must replace/ repair all equipment/ components & accessories for bad workmanship, manufacturing defects, installation/ commissioning errors or factors.
