GST (Goods and service tax has come in existence from 1st July, 2017. Contractor / Successful Bidder is bound to pay any amount of GST prescribed by the govt. of India as per the terms of contract agreed upon during the course of execution of this contract.

During the course of execution of contract, if there is any change in rate if GST (Goods and Service Tax) by the Government, the same shall be reimbursed/recovered separately by SMC. subject to the submission of original receipt/proof for the amounts actually remitted by the contractor/ successful Tenderer to the competent Authority along with a certificate from Chartered Accountant of contractor/ successful Tenderer certifying that the amount of GST paid to the government and the same shall be intimated/submitted/claimed within 30 (Thirty) days from the date of payment. Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/Tenderer, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Tenderer in this regard. Further, the non-payment of GST to the government may lead to the termination of contract and forfeiture of security Deposit/Performance Guarantee Amount.

If imposition of any other new taxes/Duties/levies/Cess or any other incidentals etc. or any increase in the existing taxes/Duties/Levies/Cess or any other incidentals etc. (Including GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Tenderer only; in no case SMC shall be liable for the same.

### (B) Eligibility Criteria:

The agencies satisfying following minimum criteria shall be considered eligible for this work:

- (B.1) The agency should have an active experience of at least 7 years in the field.
- (B.2) The agency must have completed at least 3 similar works of SETC of various types of motor-pump sets for Government or Semi Government bodies, Local self Governments, PSUs etc.
- (B.3) The agency must have a permanent set up within Surat city.

#### (C) General terms:

- (C.1) The offer must be submitted to: Executive Engineer, West (Rander) Zone, Surat Municipal Corporation Balasaheb Devsar Road, Tadwadi, Rander Road, Surat on or before Dt.23.05.2025.
- (C.2) The mode of submission: Postal RPAD or Postal Speed Post or Courier or Physical submission
- (C.3) The agency shall fill the rates in this format only.
- (C.4) This page filled with rates, experience certificates / work orders, company registration, datasheet of the product with make and model number shall be sealed in a cover. Each page of this quotation must be stamped and signed by the sending agency.
- (C.5) Following details should be written on the sealed cover: (1) Name of work (2) Address of the recipient (Executive Engineer, West Zone, Balasaheb Devsar Road, Tadwadi, Rander, Surat (3) Name and address of the sender (As actual)
- (C.6) The successful agency shall have to submit a security deposit @ a rate of 2% of the order value amount within 15 days from the award of the work order. The DD / pay order shall be issued in similar fashion as mentioned in (C.3) above. A delay penalty at a rate of 0.065% of the SD value per day will be imposed for delayed days.
- (C.6) Approved makes: Aqua / CRI / Grundfos / KSB / Kirloskar / Crompton / WPIL / M&P
- (C.7) The successful agency shall have to bind in contract with SMC. The agency shall have to submit three non judicial stamp papers each costing Rs.300/- for agreement, surety and undertaking respectively.
- (C.8) EMD of the disqualified agencies will be returned at least within 15 days after disqualification.
- (C.9) Payment: 100% payment shall be made after completion of the entire work. However, supply of item and ETC will be considered 80% and 20% respectively for each item.
- (C.10) Deductions: All the payments and deductions shall be made as per prevailing rules and standard practice of SMC.
- (C.11) The defect liability period for this work shall be 12 months after successful handover of the work to SMC. The agency shall be liable to resolve any problem within this defect liability period which includes attending the complaint, necessary repair or replacement of any or all components, resetting/retuning of the system etc.
- (C.12) Completion period: 15 Days from the date of the work order.
