The terms & conditions for this offer are as follow, failing which the quotation shall be rejected out rightly.

<u> Terms and Conditions :-</u>

- 1. The bidder shall have to quote rate inclusive of GST and all taxes, duties, Supply, Erection, testing, commission including transportation, loading unloading to complete the work in all respect.
- 2. After bidding process, any deviation in quoted rate, terms and condition shall not be entertained later.
- 3. SMC will have right to reject the offer without any reason. Decision of competent authority of Surat Municipal Corporation shall be final.
- 4. Work shall be carried out as per instruction of Engineer in charge and as per site requirement.
- 5. Bidder will have to complete above work with all respect within 20 days from date of order. If contractor fails to complete the above work than penalty @ 0.2 % of amount unexecuted work per day delayed should be recovered from your bill. Maximum delay penalty shall be recovered 10% of unexecuted amount of work order.
- 6. No payment shall be made in advance
- 7. Payment shall be done accordingly to actual work carried out at site.
- 8. 100% payment shall be released after completing SETC work and removing having teething if any and submission of Bill.
- 9. Defect liability period of the work is one year after satisfactorily commissioning of Water Cooler Machine. Under defect liability period Spares/components needed to be replaced or repaired shall be done by contractor. Contractor must replace faulty spare with genuine original manufacturer spare only.
- 10. The Bidder shall quote the rate in "price schedule". No alterations in form of tender and in "price schedule" and no additions in the shape of special stipulation will be permitted. Bidder/tenders, which do not fulfill all or any of the above conditions or are incomplete in any respect are liable to be rejected.
- 11. Successful Contractor shall be required to deposit an amount equal to 2% of total order value as Security Deposit in Cash/ by Demand Draft within 10 (Ten) days from date of work order, otherwise penalty @ 0.065% of the Security deposit Amount per day of delay shall be charged.

- 12. Successful contractor shall also be required to enter into contract agreement along with undertaking and local surety on Gujarat Stamp Paper purchased from Surat worth Rs.900.00 (i.e. 300.00 + 300.00 + 300.00 for each) (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.
- 13. Corporation will not issue any 'C' or 'D' form.

- 3. All tools, tackles, labor and material including consumables, etc required will be in scope of contractor.
- 4. All Plumbing work like Drain pipe and other piping works etc. required for execution of this work shall be in the scope of contractor. No extra payment shall be made to contractor for this.
- 5. Contractor shall have to produce an authorization letter from concern manufacturer/ distributor for post purchase service support.
