- The contractor shall quote the rate in "price schedule" only.
- The rate should be inclusive of all taxes including GST, duties, freight, labour charges and transportation etc. All tools, tackles, labour and material including consumable etc required will be in scope of contractor.
- The contractor shall be responsible for safety on site during the works. All the necessary personal protective safety equipments, material for the staff shall be bought by the contractor.
