Quotations are invited for dismantling and shifting of LMO Tank, Vaporizers, and PRS Skids at SMIMER Hospital, Surat as per following terms & conditions.

- 1. The rates should be F.O.R. destination inclusive of all taxes & charges i.e. freight, GST, packing and insurance etc.
- 2. Rate should be quoted as per serial number of list.
- 3. Items which are not found to our specifications will not be accepted.
- 4. Overwriting, erasures or correction in quotations shall not be considered.
- 5. Quotations are to be sent in sealed cover as above.
- 6. Quotations received after due date will not be considered.
- 7. The dismantling work shall be completed by the bidder within a timeframe mutually agreed upon by both parties, as specified in the Purchase Order/Work Order.
- 8. Quotations sent by post or courier or services or in person is preferable.
- 9. Guarantee/warranty (if any) should be mentioned in quotation.
- 10. Shop & Establishment registration certification should be submitted preferably.
- 11. GST CLAUSE FOR CONSTRUCTION/ ERECTION/ COMMISSIONING/INSTALLATION/
  REPAIRS/ MAINTENANCE/RENOVATION/ FABRICATION OF STRUCTURE INCLUDING

GST (Goods & Service Tax) has come in existence from 1st July, 2017. Contractor/Successful Bidder is bound to pay any amount of GST prescribed by the Govt. of India as per the Terms of contract agreed upon during the course of execution of this Contract.

During the course of execution of contract, if there is any change in Rate of GST(Goods & Service Tax) by the Government, the same shall be reimbursed / recovered separately by SMC, subject to the submission of original Receipt/Proof for the amounts actually remitted by the successful Tenderer /Contractor to the Competent Authority along with a Certificate from Chartered Accountant of Contractor / Successful Bidder certifying that the amount of GST paid to the Government and the same shall be intimated / submitted/claimed within 30 ( Thirty ) Days from the date of payment. Remittance of GST within stipulated period shall be the sole responsibility of the Successful Bidder/Contractor, failing which, SMC may recover the amount due, from

any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the Contractor / Successful Bidder in this regard. Further, the non-payment of GST to the Government may lead to the termination of the contract and forfeiture of Security Deposit / Performance Guarantee Amount.

If imposition of any other new Taxes /Duties /Levies / Cess or any other incidentals etc. or any increase in the existing Taxes / Duties / Levies / Cess or any other incidentals etc.(Excluding GST) are imposed during the course of the contract, the same shall be borne by the Contractor / Successful Bidder only, in no case SMC shall be liable for the same.

The contractor will submit the invoice to the SMC having GSTIN of SMC mentioned therein and the taxes shall be shown separately on the face of the invoice so as to claim as ITC by SMC.

This document outlines the scope of work, safety requirements, and responsibilities for the safe **dismantling and shifting** of the following equipment located near the multilevel parking of SMIMER Hospital without causing any damage to the equipment or associated piping:

## 3. Scope of Work:

### 3.1 Dismantling Activities:

- Dismantle the 20 KL LMO tank with extreme caution to prevent the tank and its connected valves and accessories.
- Dismantle both AAV 1000 vaporizers (Qty: 2).
- Dismantle both PRS skids (Qty: 2)
- Carefully dismantle all stainless steel (SS) connecting pipelines:
  - o From LMO tank to Vaporizers
  - From Vaporizers to PRS Skids
- Ensure all joints, flanges, and valves are disassembled carefully for reuse.
- Ensure no damage or deformation occurs to piping and equipment during dismantling or handling.
- Manpower, tools and gases (if any) required for the work will be under the bidders scope of work.

# 3.2 Safety Measures:

- Use certified tools and follow standard operating procedures.
- Proper PPE and fire safety measures must be in place.
- Conduct tool-box talk and risk assessment prior to job execution.

### 4. Responsibility of PI Cell, SMIMER Hospital:

Provide a suitable crane with certified lifting capacity for dismantling and lifting operations. Crane with
riggers with lifting Belts, Chain, D shackle will be provided by the crane operator at the time of
shifting/dismantling time.

- Arrange transport truck(s) for safe shifting of dismantled equipment.
- Undertake removal of fencing surrounding the LMO tank installation.
- Ensure route clearance for transport within or outside hospital premises.
- Coordinate logistics and obtain necessary safety and operation permits.

## 5. Bidder Qualification Criteria:

- The **bidder must have prior experience** in dismantling and shifting of cryogenic LMO tanks and related medical gas infrastructure.
- The execution team must include skilled and trained personnel with demonstrated knowledge of:
  - o Handling of pressurized cryogenic systems
  - Dismantling stainless steel pipelines and PRS equipment
  - o Safe transportation of high-value medical gas equipment
- Bidders must submit:
  - o Relevant work experience certificates
  - o Safety compliance records
  - o List of tools and skilled manpower to be deployed for the job.

# 6. General Requirements:

- All work shall be carried out under the supervision of qualified technical personnel.
- Equipment must be handled per manufacturer's guidelines.
- All safety and environmental protocols of the hospital and applicable regulations must be strictly followed.
