- 2 Quotation shall be sent in Sealed Cover with due description of Name of Work and Details of Sender as well as receiver and **sent through RPAD/ Speed Post or in person at address mentioned below.** SMC shall not be responsible if Covers are not received within stipulated time period.
- 3 **Sealed Covers shall be sent to: The Executive Engineer, West Zone (Rander), Balasaheb Devsar Road, Tadvadi, Surat-395009**
- 4 Quotation once accepted shall be binding to the contractor.
- 5 Conditional Quotations are straight away subject to rejection.
- 6 All duties/ taxes levied by S.M.C. and Govt. shall be payable by the contractor.
- 7 The rate quoted by the agency should be inclusive of all taxes, Service charges and Excluding GST.The Rates Quated in BOQ Should be excluding GST. GST will be reimbursed separately (if applicable as per the opinion of Account department of SMC / GST Consultant of SMC) as per the prevailing GST Rates decided by the Government. The contractor is invariably bound to any changes in GST Rates made during the course of the work. Decision of Account Department of SMC regarding applicable GST Rates will be final.  
Construction Cess will be deducted from all Running Bills & Final Bills as per the prevailing Government Rates.
- 8 **The decision of Competent Authority of SMC shall be final in respect of disputes what so ever arise.**
- 9 It is mandatory to submit **E.M.D. of Rs. 10,000/-** with Quotation in form of Demand Draft. Failing to this will result in rejection of quotation / bid.
- 10 Multiplication of Rates with Quantity shall have precedence over the amount in case of ambiguity.

- 11 **Security Deposit of 2%** of the Work Done shall be deducted from each Running Bill This Deposit shall be released after Completion of the Audit related Quarries if any.
- 12 Successful tenderer has to execute Agreement incl. Surety and Undertaking on the Stamp Paper of **Rs. 300/- within 5 Days** of issuing Work Order.
- 13 Safety of Manpower / Machinery will be complete responsibility of the Tenderer. All the precautions and safety measures shall be taken by tenderer. SMC or any person of SMC will not be responsible in any case of accident or loss of life.
- 14 The successful tenderer shall be constituted according to and subject to Laws in India and State of Gujarat and under the jurisdiction of Courts of Gujarat at Surat City.
- 15 SMC may divide / split the work among multiple bidders / Contractors as per the requirement. Bidders are obliged to work accordingly.
- 16 As far as the rates are concerned, the Competent Authority / SMC will finalize the rates & will obtain necessary consent if required so.
- 17 Bidder shall be required to submit the enlisted documents along with Bid, E.M.D. If documents are insufficient or it does not match the required criteria mentioned below, then the Bid of the bidder shall not be qualifyMainly bidder shall fulfill following the qualification.
  - (a) Experience of having successfully completed similar works during last 7 years.
    - (1a) Three similar completed works, each costing not less than amount equal to 40% of the estimated cost. OR
    - (2a) Two similar completed works, each costing not less the amount equal to 50% of the estimated cost.OR
    - (3a) One similar completed works, each costing not less the amount equal to 80% of the estimated cost.
  - (b) Solvency certificate issued by Nationalized/Scheduled Bank of Rs 3.00 lacs min.
  - (c) Professional Tax Registration Certificate & GST Registration Certificate.
