1. All the rates should be **Including GST** and including of all other taxes duties, labor charges and transportation, loading unloading, watch and ward etc. up to delivery at East (Varachha) Zone -A, **Swami vivekanand Auditorium**. Fulfilments of this condition are must or else the quotation shall be liable for outright rejection.
2. Rates must be filled in this quotation paper only and returned duly sealed & signed.
3. In case of any misunderstanding due to interpretation of any terms, conditions or specifications the decision of Executive Engineer, East Zone - A, Surat Municipal Corporation, Surat shall be final and binding on the part of contractor.
4. Price variation clause of any form shall not be accepted. Price shall remain firm till end of contract.
5. No correction, overwriting erasures in filling Quotation papers shall be considered unless countersigned. The material shall be supplied within 7 days of work order given.
6. No payment shall be made in advance.
7. 100% payment shall be released after supply of material as per requirement and submission of Bill.
8. If contractor fails to complete above work than penalty @ 0.2 % of amount unexecuted work per day delayed should be recovered from your bill. Maximum delay penalty shall be recovered 10% of unexecuted amount of sub work order.

9. Corporation will not issue any 'C' or 'D' form.
10. The contractor will not be provided any transportation fare or other charges.
11. Conditional Quotation shall not be accepted..
12. The work should be completed within 30 days from the date of Work order.
