Condition of work :-

- 17. In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
- 18. The offer shall remain valid up to 120 days from the date of receipt of the quotation.
- 19. The name of work i.e. "Quotation for the work of....... "must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.
- 20. Contractor will have to take hand over of all the U.P.S. on as & where basis and if there is repairing of any U.P.S. including minor or major parts, it is in scope of contractor.
