### **Work Conditions:-**

#### 1.0 Workmanship

- 1.1 Maintain the safety measures for the workmen, public etc is prime important and contractor/bidder has to maintain to their own cost, in any case.
- 1.2 Worker must have safety helmet, safety jacket, safety shoes, safety belt, safety gloves etc. and he/they must be wear these all accessories during demolition activity.

- 2.2 Quotation EMD of Rs.14,500/- in pay order or by demand draft of any nationalized bank, in favour of "Commissioner, Surat Municipal Corporation, Surat" payable at Surat and shall be submitted with other documents. Surat Municipal Corporation shall not be liable for any postal delay in any case.
- 2.3 The Successful quotationer will be required to furnish a performance bond (Security Deposit) of an amount equal to 2.0% (Two percent) of the Awarded amount.
