- (3) Quotation once accepted shall be binding to the Vendor/Contractor.
- (4) Quoted rate must be **WITHOUT GST** & include all other taxes, duties/ levies, freight, insurance, transportation, delivery and Loading unloading at the site etc Complete.
- (5) The decision of Deputy Commissioner shri, Public Infrastructure Cell, SMC shall be final in respect of disputes what so ever arise.
- (6) Right to accept any or to reject any or all the offers without assigning any reason thereof is reserved by the competent authority of Surat Municipal Corporation. Surat.
- (7) All necessary safety measures and precautions (including those laid down in the various relevant Indian Standards) shall be taken to ensure the safety of men, materials and machinery on the works as also of the work itself.
- (8) Overall lowest bidder shall be taken for consideration.
- (9) Conditional offer shall not be accepted.
- (10) **Defect liability period for the above entire work shall be of Two (02) year from the work completion.**
- (11) The contract shall be constituted according to and subject to laws in India and state of Gujarat and under the jurisdiction of courts of Gujarat at Surat City only.
- (12) **An EMD of Rs.2,400/- in form of DD or Pay Order issued in favour of 'Commissioner, Surat Municipal Corporation' and payable at Surat must accompany this quotation.**
- (13) All the payments shall be made as per prevailing rules of SMC.
- (14) The successful bidder shall have to submit a security deposit at rate of 2 % of the awarded value within 15 days from the date of the work order. Failing of submitting security deposit within 15 days shall lead to a delay penalty at a rate of 0.065% of SD value per day.
- (15) The successful bidder shall have to bind in agreement with Surat Municipal Corporation. Bidder shall have to submit 3 non judicial stamp papers each costing Rs.300/- for agreement, surety and undertaking respectively.
- (16) The completion period shall be 15 days from the issuing date of the work order. Penalty shall be levied **0.2% of unexecuted work** per day up to maximum **10% of the total contract value** shall be charged from running bill of the contractor if the work is not completed within stipulated time limit.
- (17) 95% Payment shall be release after satisfactorily completion work. Remaining amount shall be released in final bill. after 15 Days of completion of the work and submission of bill.
- (18) 7% of work done amt. shall be retain from each running bill which will be released in final bill
