- Bidder shall have to submit this Quotation paper and along with relevant GST Registration Certificate, PAN Card under the sealed envelope and write "QUOTATION", mention name of work, name and address of agency/contractor on sealed envelope Else the quotation will be rejected.**
- Bidder shall have to quote prices inclusive levies, loading, unloading, transportation, labour charges etc & Exclusive of GST.
- Bidder must visit the site before quoting to understand the type and requirement of the work. No dispute of any kind shall be entertained after finalizing quotation.**
- Time Limit for whole work will be 10 Days from the date of work order. In case of work is delayed, then penalty will be recovered at 0.2% of bidding amount per day of delay of work order cost that will be maximum up to 10% of delayed work.

5. Successful bidder must have to submit security deposit (SD) of amounting 2.5% of quoted amount, after sanction work in form of Cheque/DD/Pay order only and SD of successful bidder will be released after satisfactorily completion of work.
6. Successful bidder shall have to undergo Agreement, Surety and Undertaking 300 stamp paper each as per SMC prevailing rules within 10 days from the date of work order.
7. Defect liability period shall be 12 month after completion of the work.
8. Payment Condition:- 100% payment will be released after satisfactory completion of work and submission of invoice within 30 days.
9. The Quotation shall remain valid for a period of 120 days from the date of opening of bid and that the Bidder shall not be allowed to withdraw or modify the offer during this period.
10. Bidder must submit Experience Certificate/Work order/Any relevant document showing experience of SETC/Repairing of Chlorine Scrubber system work.
