GST (Goods and service tax has come in existence from 1st July, 2017. Contractor / Successful Bidder is bound to pay any amount of GST prescribed by the govt. of India as per the terms of contract agreed upon during the course of execution of this contract.

During the course of execution of contract, if there is any change in rate if GST (Goods and Service Tax) by the Government, the same shall be reimbursed/recovered separately by SMC. subject to the submission of original receipt/proof for the amounts actually remitted by the contractor/ successful Tenderer to the competent Authority along with a certificate from Chartered Accountant of contractor/ successful Tenderer certifying that the amount of GST paid to the government and the same shall be intimated/submitted/claimed within 30 (Thirty) days from the date of payment. Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/Tenderer, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Tenderer in this regard. Further, the non-payment of GST to the government may lead to the termination of contract and forfeiture of security Deposit/Performance Guarantee Amount.

If imposition of any other new taxes/Duties/levies/Cess or any other incidentals etc. or any increase in the existing taxes/Duties/Levies/Cess or any other incidentals etc. (Excluding GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Tenderer only, in no case SMC shall be liable for the same.

- 5. The decision of Executive Engineer, West Zone, SMC shall be final in respect of disputes what so ever arise.
- 6. Right to accept any or to reject any or all the offers without assigning any reason there of is reserved by the competent authority of Surat Municipal Corporation. Surat.
- 7. Accordingly the contractor shall have to quote and submit within stipulated time limit.
- 8. Overall lowest bidder shall be taken for consideration.
- 9. Conditional offer shall not be accepted.
- 10. All necessary safety measures and precautions (including those laid down in the various relevant Indian Standards) shall be taken to ensure the safety of men, materials and machinery on the works as also of the work itself.
- 11. The contract shall be constituted according to and subject to laws in India and state of Gujarat and under the jurisdiction of courts of Gujarat at Surat City only.
- 12. Successful bidder shall have to submit a Security Deposit for amount equal to Two percent (2.5 %) of the contract price by a demand draft issued in favor of "Commissioner, Surat Municipal Corporation" and payable at Surat. If security deposit is not submitted within 10 days from the date of the work order, a delay penalty at a rate of 0.065% of SD amount shall be enforced. Security deposit will be returned to the contractor after successful completion of the work.
- 13. The successful contractor shall have to bind in an agreement with SMC for the stated work. The contractor shall have to submit 3 non judicial stamp papers each of Rs.300/- for agreement, surety and undertaking respectively.
- 14. All the payments and deductions shall be made as per prevailing rules of SMC.
- 15. The sealed cover containing the offer shall reach to "Executive Engineer, Surat Municipal Corporation, West Zone, Surat-395009" on or before Dtd.14 .11.2025, 17.00 Hrs. The offer shall be submitted to Govt Speed Post/ Currier only.
- 16. The cover shall contain the name of the work, last date of submission and name and address of the agency.
