SCOPE OF WORK

- Please visit the site and get acquainted with site situations before quoting the price. No dispute at later date shall be entertained.
- > Only qualified and experienced person/s must be employed for job. The corporation will not be responsible for any accident or injury to the workman/staff of the contractor. No compensation of any kind shall be paid by the corporation. The contractor shall observe all applicable latest Government rules and regulation regarding this type of work, etc.
- > The contractor shall quote the rate in "Price Schedule". No alterations in form of tender and in "Price Schedule" and no additions in the shape of special stipulation will be permitted. - All efforts will be taken and sufficient arrangement shall be made by contractor to prevent inconvenience to performers/personal arranging the program. Deputed person should remain polite and co – operative with the program organizer and should strictly follow instruction of Manager.

- > Contractor shall comply with all safety rules and regulations and all inter disciplinary measures followed by the corporation. The corporation shall not responsible for any accident/injury to the staff of the contractor. It is contractor's responsibility to take insurance of his employee and to provide medical facilities and workman compensation etc. to the staff.
- > Surat Municipal Corporation has reserved all the rights to accept or to reject any or all the quotation without assigning any reasons thereof.
- > No correction, overighting, erasers in filling quotation shall be considered unless countersigned.
- > The person below the age of 18 years shall not be permissible.
- > During the execution of work, the contractor should properly cover-up and protect the instruments/controllers/machines liable to damage or deterioration by expouser to the weather and should also take every precaution against damage to the machinery from any cause. If any problems happen in equipment during program, contractor should arrange for the same for a time being. Repairing of faulty equipment shall be done by SMC.
- > Contractor should have to provide identity card to the deputed person and it should be get endorsed from manager of Sardar Patel Smruti Bhavan Auditorium. Deputed person should be dressed properly with good appearance.
- Rates shall be quoted for a program of 3.5 hours. Extra payment shall be made per 30 minutes if program exceeds its the limit .Moreover, these rates shall be applicable to any type of program e.g. Meeting /Seminar/ Promotional Event / Play /Cultural or Dance programs etc.

- 1. If in any program operator will not remain present than penalty should be charged Rs.1000/- per program.
- 2. If the employee of contractor damages any part of the sound system while transferring, handling or operating, the expense behind the repair plus a penalty of Rs.500/- per incidence shall be levied.

Note: The contract will be terminated at any time without any notice/reasons as per convenience of Surat Municipal Corporation.

2. TIME LIMIT / WORK COMPLETION PERIOD

- Work shall be carried out for the period of 2 years or the financial limit of Rs. 5 lacs whichever is earlier
- However the work may be extended when as the term & conditions mutual agreement with SMC and contractor if smc desire
- Time limit will be considered after 10 days of the work order issued.

3. Documents/Experience Required: -

- The contractor shall have an active experience within least 07 (Seven) years in similar works. ie Sound system Operation.
- Solvency Certificate (Amount Rs. 1,00,000.00)

4. PRICES AND PAYMENTS: -
