Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/ Bidder, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Bidder in this regard. Further, the non-payment of GST to the government may lead to the termination of contract.</p> <p>If imposition of any other new taxes/ Duties/ levies/ Cess or any other incidentals etc. or any increase in the existing taxes/ Duties/ Levies/ Cess or any other incidentals etc. (Excluding GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Bidder only; in no case SMC shall be liable for the same.</p>

**Name of Work: - Supply of different type of Electrical Accessories/ Materials at Central Zone
Light Department of Surat Municipal Corporation**

- The rate should be including all other taxes, duties, labor charges, GST and transportation, loading unloading, watch and ward etc.
- **EMD of Rs.2000.00 (Rupees Two thousand only)** shall be deposited in form of Demand draft/Pay order in favor of Surat Municipal Corporation Quotation without EMD shall be rejected.
- Bidder must provide warranty for supplied items as per Manufacturer's warranty.
- The firm will have to supply Electrical Material within 7 days from sub work order/oral order of Light department of SMC. if not, the SMC will get it from other contractor and additional expenditure so incurred on such supplied items including administrative charges will be deducted from the balance payment, due for payment to contractor.
- In case of unsatisfactory performance Corporation may terminate this contract and to debar & to disallow the contractor in future tendering in SMC forfeiting, the security deposit.
- The services should be provided on regular basis during office hours. In case of emergency contractor must supply above Electrical Items beyond office hours & on holiday as well. Materials should be supplied within 7 days as intimated by SMC. Failing which penalty @ 0.2% of order value of unexecuted portion per day of delay subject to maximum 10% of unexecuted portion order value shall be charged and shall be deducted from the bill.
- The successful contractor shall also be required to enter into contract **agreement** along with undertaking and local surety on Gujarat Stamp Paper purchased from Surat worth Rs.900.00 (i.e. 300.00 + 300.00 + 300.00 for each) (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.
- The successful Contractor shall be required to deposit an amount equal to **2% of the total order value as Security Deposit** Municipal Treasury in Cash/ by Demand Draft within 15 (Fifteen) days of order failing which penalty @ 0.065% of the Security Amount per day of delay shall be charged.
- The period of Annual Rate Contract for Supply of Electrical Materials will be One (1) year from the date of the award of the contract for total amount of ₹ 2 lakh whichever is earlier.
- SMC will not pay any transportation charges and also not provide any type of assistance which carrying out above mention work. Contractor must replace faulty spare with genuine spare only.
- material shall be supplied to electrical office at central zone
- The rates quoted shall remain in force for full period of contract.
- All Mentioned Electrical items supplied as per Vendor list only.
- Validity of quotation shall remain 120 days from opening date of the Quotation.
- No Payment shall be made in advance Payment shall be made within 60 days after safe receipt & inspection/ testing of material Satisfactory Completion of work
- Rates must be filled in this quotation paper only and returned duly sealed & signed.
- The name of work i.e. "Quotation for Supply of Different type Electricals Accessories/Materials at Central Zone Light Dept. S.M.C must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.
- The offer shall be submitted in a sealed cover to " **Executive Engineer, Central Zone, Surat Municipal Corporation, New Admin building, Muglisarai, Surat-395003**".
- **Contractor must have to submit the Quotation with two separate covers.** In Cover-I Technical parts of Quotation papers, such as EMD, ,GST Registration etc, is to be attached and in Cover-II only Price Schedule is to be attached and also note that these both cover must be submitted in Cover-III which is to be mentioned the Name of Work on the Envelope.
- While opening of quotation, Technical Bid shall be opened first, after evaluating technical bid document for qualification, Price bid of technically qualified contractor shall be opened only.
