**SCOPE OF WORK, TERMS & CONDITION :-**

- Tenderer shall have to Supply, Erection, testing & commissioning of Streetlight LED Luminaries on existing streetlight pole where existing 15 Watt LED Streetlight has been dismantle & take it for buyback working at Varrious Society Internal road under New East (Sarothana) Zone. Part-2 area.
- Contractor must approve sample of LED Luminaries before Placing Purchase Order/Installation for which necessary Technical data sheet (along with driver(s), LED chip(s) to be used, LM 79, LM 80, Relevant BIS Certificate, Type Test Report, etc...) as well as Physical sample must be submitted for Technical/Physical Verification. Proof must be provided by the manufacturer of Luminaries for make of LED chip used in Luminaries
- Material/Supply shall be free from any defect and as per Technical Specs. Only.
- All Miscellaneous Work/activities i.e. reducer/nipple required for LED installation are in the scope of contractor. Hence, Bidders are advised to visit Site/Location before quoting Price.

- Contractor shall have to provide necessary documents to prove genuineness of material up to the satisfaction of engineer in charge. The payment will be made only after approval of genuineness.
- Contractor shall directly follow the instructions by the SMC representative/ authorized personal from concerned department at the site.
- Defect liability period shall be 1 (One) year from the commissioning of the Streetlights at site.
- All employees deployed for the said work shall be provided with personal safety equipments & accessories. Contractor shall be responsible to the accident/injury/Loss to any of the staff members of them.
- Contractor shall follow all applicable laws, rules, regulation for such type of work.
- Quotation once offered shall not be withdrawn.
- Quotation once accepted shall be binding to the contractor.
- The Rate should be all duties/ taxes (Except GST), Transportation material & labour cost. all duties/ taxes levied by S.M.C. or any Govt. Department shall be payable by the contractor.
- Right to accept any or to reject any or all the quotation without assigning any reason thereof is reserved by the competent authority of Surat Municipal Corporation, Surat.
- The decision of Divisional head of New East (Sarothana) Zone will be final in respect of disputes what so ever arise.
- In absence of EMD, the Quotations will be Liable to be rejected.
- Quantity of items may be actually reduced or increased during actual execution of work, contractor shall carry out the work accordingly.
- The contract shall be constituted according to and subject to laws in India and state of Gujarat and under the jurisdiction of courts of Gujarat at Surat City only.

**TIME LIMIT / WORK COMPLETION PERIOD:-**

- Time limit of the work is 30 days from the issue of work order date. If the contractor fails to complete the work within the stipulated completion date for the work or he shall pay liquidated damages 0.20% of contract value per day of delay in completion or part thereof as the case may however, be subjected to a maximum of ten (10) percent of the contract value.

**SECURITY DEPOSIT/AGREEMENT/STAMP DUTY:-**

- Successful Contractor shall be required to deposit an amount equal to **2.0% of total order value as Security Deposit** in Cash/ by Demand Draft within 10 (Ten) days from date of work order, otherwise penalty @ 0.065% of the Security deposit Amount per day of delay shall be charged.
- Successful contractor shall also be required to enter into contract agreement on Gujarat Stamp Paper purchased from Surat worth Rs.300.00 for each i.e. Contract agreement, Surety & Undertaking (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.

**PRICES AND TERMS OF PAYMENTS: -**

- **All rates should be quoted Excluding GST.**
- Contractor must understand clearly that the prices quoted are for the total works i.e. include all Material/Spares, labour, supervisions, transportation, loading, unloading, watch and ward etc. excluding GST. No claim for additional payment beyond the prices quoted will be entertained and contractor will not be entitled subsequently to make any claim on any ground.
- No payment shall be made in advance.
- Payment shall be released after completion of said work.
- Corporation will not issue any 'C' or 'D' form.
- Applicable GST + TCS on Buyback paid Extra by Tenderer.
