- The work include surface before painting shall be cleaned of all rust, scale, dirt and other foreign matter sticking to it with wire brushes, steel wool, scrapers, sand paper etc. Providing and applying painting of One coat of Zinc Phosphate Red Oxide as a primer and second coat of synthetic enamel paint.
- The work include all machineries thoroughly and making them working and also repairing / replacement of damage parts also in the scope of work.
- Prior to submitting quotation bidder shall have to visit the site and determine the scope of work with in charge engineer.

TERMS AND CONDITIONS:-

The bidder shall submit the quotation under a Three-Cover System as detailed below:

- **Cover-1: Technical Bid** – Comprising all documents in support of eligibility criteria, technical compliance, experience credentials, statutory registrations, and other requirements as stipulated in the tender document.

- **Cover-2: Financial (Price) Bid** – Containing only the duly filled-in price schedule.
- **Cover-3: Main Cover** – Enclosing Cover-1 (Technical Bid) and Cover-2 (Financial Bid).

The Technical Bid (Cover-1) shall be opened first and evaluated for responsiveness and qualification in accordance with the conditions.

The Financial Bid (Cover-2) shall be opened only after completion of the technical evaluation and only in respect of bidders declared technically responsive and qualified. Financial Bids of technically non-responsive bidders shall not be opened.

1. Successful Bidder shall have to furnish a performance guarantee (Initial S.D. Deposit) for amount equal to 2.5% of the contract amount by a demand draft of a Scheduled Nationalized Bank acceptable to owner on the Surat Branch. Security Deposit shall be paid in time and if it is paid after Ten (10) days from the date of work order, then the penalty of 0.065 % per day of the amount of Security Deposit shall be recovered from the contractor. The performance guarantee (Security Deposit) will be returned to the contractor after the defect liability period (Six month) after completion of work) and on completion of audit related procedure.
2. **Time Limit for whole work will be 45 Days.** In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
3. Successful agency shall have to enter in to Rs. 300 Agreement & Undertaking on suitable Gujarat State stamp paper.
4. **The rate should be inclusive of all taxes, duties, GST and labor charges and transportation etc.**
5. The offer shall remain valid up to 120 days from the date of receipt of the quotation.
6. Corporation reserve the right to accept or reject any or all the quotation without assigning any reason therefore.
7. The contractor shall be responsible for and shall pay any compensation to his workmen payable under the Workman's Compensation Act 1923 (VIII of 1923) or any statutory modification thereof for injuries caused to their workmen during working hour.
8. Tenderer shall comply with all labour, industrial laws including Contract Labour (Regulation and Abolition) Act, 1970 and such other Acts and Statutes as may be applicable to him for the employees employed by him in connection with the work of this contract of the SMC. The contractor will be held responsible for safety, security, insurance, compensation etc. in his personals/operators / worker during the execution of work/contract.

10. Any loss, damage to SMC property due to the carelessness of the contractor in work, all will be deducted from contractor's bill.
