GST (Goods and service tax has come in existence from 1st July, 2017. Contractor / Successful Bidder is bound to pay any amount of GST prescribed by the govt. of India as per the terms of contract agreed upon during the course of execution of this contract.		
During the course of execution of contract, if there is any change in rate if GST (Goods and Service Tax) by the Government, the same shall be reimbursed/recovered separately by SMC. subject to the submission of original receipt/proof for the amounts actually remitted by the contractor/ successful Tenderer to the competent Authority along with a certificate from Chartered Accountant of contractor/ successful Tenderer certifying that the amount of GST paid to the government and the same shall be intimated/submitted/claimed within 30 (Thirty) days from the date of payment. Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/Tenderer, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Tenderer in this regard. Further, the non-payment of GST to the government may lead to the termination of contract and forfeiture of security Deposit/Performance Guarantee Amount.		
If imposition of any other new taxes/Duties/levies/Cess or any other incidentals etc. or any increase in the existing taxes/Duties/Levies/Cess or any other incidentals etc. (Excluding GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Tenderer only; in no case SMC shall be liable for the same.

**(A) Contract Terms**

**A.1** The contract period shall be **1 year** as mentioned in the work order, or until the expenditure limit of **Rs. 2,00,000/- (including GST)** is reached, whichever occurs earlier. The per-meter rate quoted by the contractor shall remain fixed throughout the contract period.

**A.2** All quoted rates must be **inclusive of GST, taxes, duties, levies, labor charges, transportation, loading/unloading, and delivery** to the West Zone (Rander) Light Department.SMC.

**A.3** Rates must be filled in the **financial documents of this quotation only** and returned duly sealed and signed.

**A.4** In case of any dispute or misinterpretation of terms, conditions, or specifications, the decision of the **Executive Engineer, West Zone (Rander), Surat Municipal Corporation** shall be final and binding.

**A.5** Price variation clauses will not be accepted. Prices shall remain firm until the end of the contract.

**A.6** Materials must be supplied within the time limit mentioned in the work order or as per requirement.

**A.7** Conditional quotations will not be accepted.

**A.8** The agency must follow the **approved vendor list**.

**A.9** The agency must be **local** and have an office within Surat city limits.

**A.10** SMC reserves the right to terminate the contract at any time during the contract period without prior notice.

**(B) Scope of Work**

**B.1** The contractor shall supply electrical wires and cables as per SMC's requirements and/or sub-work orders. Intimation may be given verbally, telephonically, via messages, emails, or in writing.

**B.2** If supplied materials are found to be non-genuine, defective, or not brand new, punitive action will be taken, including cancellation of the contract and blacklisting of the agency.

**B.3** Each material carries a **defect liability of one year**. Any manufacturing defect within this period must be replaced free of cost.

**B.4** The agency must be able to supply materials throughout the year, including Sundays and public holidays, depending on urgency.

**B.5** The agency shall comply with all applicable laws, rules, and regulations

**B.6** SMC may demand **factory test certificates (FTCs)** for supplied materials, which the contractor must provide .

**B.7** SMC will not be responsible for any accident, injury, or death of contractor's employees/manpower. No compensation will be paid in such cases.

**(C) Financial Terms**

- C.1** Each offer must be accompanied by an **EMD of Rs. 2,000/-** in the form of DD/Pay Order in favor of Commissioner, Surat Municipal Corporation, payable at Surat.
- C.2** EMD of unsuccessful bidders will be returned within 15 days of awarding the work order. EMD of the successful bidder will be returned after completion of agreement procedures and deposition of security deposit.
- C.3** The successful agency must deposit a **security deposit of 2.5% of the order value** in cash or DD/Pay Order in favor of Commissioner, Surat Municipal Corporation, payable at Surat.
- C.4** Security deposit must be submitted within 15 days of the work order. Delay will attract a penalty of **0.065% of the SD amount per day**.
- C.5** The successful agency must execute a contract with SMC by submitting **three non-judicial stamp papers of Gujarat State**.
- C.6** No advance payment will be made. Payments will be released on a **quarterly basis** as per prevailing rules and practices of SMC.
- C.7** GST will be reimbursed only upon submission of valid proof of payment to the Government.

**(D) Penalty Criteria**

- D.1** For work delay, 0.2% (zero point two percent) of the tender value of the unexecuted work shall be levied per day of delay, subject to a maximum of 10% of the unexecuted work amount.

---

**(E) Offer Submission**

- E.1** The offer shall consist of **two parts – Technical and Financial**.
- E.2 Cover-I (Technical):** Must contain signed and stamped technical documents, including GST registration, PAN card, firm registration, experience certificates (supply of electrical goods), purchase/work orders, and **original EMD draft**. Third-party documents must be notarized.
- E.3 Cover-II (Financial):** Must contain only the rates offered, duly signed and stamped.
- E.4** Both covers must be sealed in **Main Cover-III**, clearly mentioning the name of work, agency details, and last date of submission.
- E.5** Offers must be submitted to:
