**SCOPE OF WORK, TERMS & CONDITION :-**

- Tenderer shall have to Supply, Erection, testing & Commissioning of 2 HP, 3 phase openvell submersible pump set at Maharaja Bhagavatsinhji Prathmik School – 353, Mota Varachha and 1 HP single phase monoblock pump set at Ward Office, Umara.
- Scope of work involves supply, installation, Testing and commissioning of Pump set, starter, cabling and connection with existing power supply.
- Material/Supply shall be free from any defect and as per vendor list only.
- Contractor shall directly follow the instructions by the SMC representative/ authorized personal from concerned department at the site.
- Defect liability period shall be One year from the commissioning of the pump at site.
- All employees deployed for the said work shall be provided with personal safety equipments & accessories. Contractor shall be responsible to the accident/injury/Loss to any of the staff members of them.
- Contractor shall follow all applicable laws, rules, regulation for such type of work.
- Quotation once offered shall not be withdrawn.
- Quotation once accepted shall be binding to the contractor.
- The rate should be **Excluding of GST** and including of all other taxes, duties, labor charges and transportation, loading unloading, watch and ward etc. at Site.

- Right to accept any or to reject any or all the quotation Without assigning any reason thereof is reserved by the competent authority of Surat Municipal Corporation, Surat.
- The decision of Divisional head of New East (Sarhana) Zone will be final in respect of disputes what so ever arise.
- In absence of EMD, the Quotations will be Liable to be rejected.
- Quantity of Items may be actually reduced or increased during actual execution of work, contractor shall carry out the work accordingly.
- The contract shall be constituted according to and subject to laws in India and state of Gujarat and under the jurisdiction of courts of Gujarat at Surat City only.

**TIME LIMIT / WORK COMPLETION PERIOD:-**

- Time limit of the work is 15 days from the issue of work order date. If the contractor fails to complete the work within the stipulated completion date for the work or he shall pay liquidated damages 0.20% of contract value per day of delay in completion or part thereof as the case may however, be subjected to a maximum of ten (10) percent of the contract value.

**SECURITY DEPOSIT/AGREEMENT/STAMP DUTY:-**

- Successful Contractor shall be required to deposit an amount equal to **2.5% of total order value as Security Deposit** in Cash/ by Demand Draft within 10 (Ten) days from date of work order, otherwise penalty @ 0.065% of the Security deposit Amount per day of delay shall be charged.
- Successful contractor shall also be required to enter into contract agreement on Gujarat Stamp Paper purchased from Surat worth Rs.300.00 (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.

**PRICES AND TERMS OF PAYMENTS: -**

- **All rates should be quoted excluding GST.**
- Contractor must understand clearly that the prices quoted are for the total works i.e. include all Material/Spares, labour, supervisions, transportation, loading, unloading, watch and ward etc. excluding GST. No claim for additional payment beyond the prices quoted will be entertained and contractor will not be entitled subsequently to make any claim on any ground.
- No payment shall be made in advance.
- Payment shall be released after completion of said work.
