Validity of quotation :-	120 Days.
Payment condition :-	100% Bill will be Paid after completion of work & Submission of invoice. All applicable taxes and cess will be deducted from this bill as per prevailing norms.

TECHNICAL NOTES:

- A. The Scope includes Labour Work & Supply (if necessary).
- B. Pump sets with accessories like pump, MS/SS pipes, chain, cable, NRV, KGV etc including starter panel etc. will be issued by drainage department.
- C. Transportation of pump sets, pipes, starter panel & Loading-unloading from Drainage Department Stores/assigned places in the city within where material is stored to Pal Sewage Pumping Station is in the scope of contractor / tenderer.
- D. Lowering, Erection, commissioning & testing of pump sets with accessories as per in-charge Engineer's instruction to assigned sites should be in the scope of contractor/ tenderer.
- E. All required material like rubber packing, nut-bolts, flange and etc. for erection shall be in the scope of contractor.
- F. The Scope of work also includes replacement of existing delivery pipeline with new delivery pipeline with necessary fabrication work at Pal Sewage Pumping station of Drainage Department.
- G. Fabrication of piping labour work is in the scope of contractor.
- H. The Contractor has to carry out necessary civil works for Pump set installation also for this job like foundation etc. The contractor shall complete the civil works at his cost i.e. cost of labor cement, sand, bricks, M.S. bars, etc. shall be included.
- I. Cable installation work including tracing, termination and other required work .
- J. Other work which is necessary and not included in above, should be in the scope of contractor.
- K. Please note that sufficient care should be taken during handling of the items to prevent damage. All tools Tackles / Caution etc. required for safety as per govt. norms is in the scope of Contractor.
- L. Contractor has to take all necessary safety measures as per safety guidance.

NOTE:-

1. Successful agency shall enter into contract agreement on suitable Gujarat stamp paper and depositing an amount equal to 2.5 % of order value as security deposit in municipal treasury in the form of Cash/Demand Draft/Pay Order of any Nationalized bank/scheduled bank of Surat branch and drawn in favor of Municipal commissioner, Surat municipal corporation within 15 days from the date of work order otherwise, penalty @ 0.065% of the amount of security deposit per day of delay shall be levied.
2. Following formalities should be completed within 15 days. The successful Contractor has to submit three number of Non judicial e-stamp paper of Government of Gujarat each of Rs.300/- for agreement, surety and undertaking respectively.
3. The performance guarantee (Security Deposit) will be returned to the contractor after **two months of completion of work and on completion of audit related procedure.**
4. **Time Limit for whole work will be 30 (Thirty) Days from the date of work order.** In case of work is delayed, then penalty will be recovered at 0.2% of tender amount per day of delay of work order cost that will be maximum up to 10% of delayed work.
5. **The Contractor shall have to submit a Work order/Work Completion Certificate of similar nature work.**
6. The rate should be inclusive of all taxes, duties, and labor charges and transportation but excluding GST etc.
7. The offer shall remain valid up to 120 days from the date of receipt of the quotation.
8. Corporation reserve the right to accept or reject any or all the quotation without assigning any reason therefore.
9. The offer must be in the format attach herewith only otherwise offered will be rejected.

10. Any loss, damage to SMC property due to the carelessness of the contractor in work, all will be deducted from contractor's bill.
11. Payment should be done as per actual complete work at Drainage Dept.
12. Rate must be filled in this quotation paper only and returned duly sealed & signed.
13. The name of work i.e." Quotation for the work of..... "Must be mentioned on the envelope without which quotation is likely to be rejected, which must be noted.
