2. The successful Contractor has to submit three number of Non judicial e-stamp paper of Government of Gujarat each of Rs.300/- for agreement, surety and undertaking respectively.
3. The performance guarantee (Security Deposit) will be returned to the contractor after the completion of audit related procedure.
4. **Time Limit for whole work will be 30 Days from the date of work order.** If contractor fails to complete above work than penalty @ 0.2 % of amount unexecuted work per day delayed should be recovered from your bill. Maximum delay penalty shall be recovered 10% of unexecuted amount of work order.
5. The rate should be inclusive of all taxes, duties, and labor charges and transportation but excluding GST etc.
6. The offer shall remain valid up to 120 days from the date of receipt of the quotation.
7. Corporation reserve the right to accept or reject any or all the quotation without assigning any reason therefore.
