Scope of Work:

[1] Scope of Restoration Work

- 1.1. Supply of required electrical materials such as AC/DC cables, connectors and other accessories as per site requirements.
- 1.2. The agency shall visit the location and installation site to inspect the site conditions before execution of work.
- 1.3. Carrying out all necessary works including laying of DC cables, installation and termination of MC4 connectors, cable dressing and tracing, inverter termination, interconnection wiring, complete system integration, testing & commissioning, and restoration of affected areas after completion of work.
- 1.4. The contractor shall coordinate for necessary permissions and approvals required during execution of work from Surat Municipal Corporation, wherever applicable.

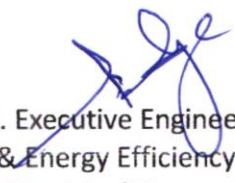
Terms and Condition of the Quotation

1.	Submission of Quotation:	On or before 05/08/2026 @ 06:00 PM. Address: - Light & Energy Efficiency Cell, Room No: 117, 3rd Floor, Main Office Building, Surat Municipal Corporation, Shri Tapi Bhawan, Surat Mahanagar Seva Sadan, Tapipura, Muglisara, Surat- 395 003. Quotation with improper information, incomplete details shall not be accepted. GST Registration Certificate and valid Electrical Contractor License must be furnished along with the quotation.
2.	Validity of Quotation:	60 Days from the date of opening of the Quotation.
3.	All Taxes/ Duties, etc. applicable:	Rates must be inclusive of all taxes/ duties inclusive GST, Site Visit. Amount of applicable GST must be mentioned in the quotation. Fulfillment of these conditions is must or else the quotation shall be liable for outright rejection.
4.	Time Period:	4 (four) weeks from the date of Work Order.
5.	Penalty Criteria:	The work must be completed in all respect within stipulated time period as mentioned earlier (TIME REQUIRED FOR COMPLETION), failing which penalty @ 0.2 % of order value of unexecuted portion per day of delay subject to maximum 10 % of order value shall be charged and shall be deducted from the bill or any outstanding payment. Also, if contractor fails to execute the work than action against contractor will be taken as per decision of competent authority of SMC and that should bind to contractor.
5.	Security Deposit (SD):	5 % of total Work Order Amount. It will be Released after satisfactory completion of work.
6.	Work/ Contract Agreement:	To be entered into agreement, Surety & undertaking on Rs. 300.00 non judicial stamp paper each purchased from Gujarat state only within 10 days from the date of order
7.	Payment Condition:	- No advance Payment of any kind shall be paid by the corporation. 100% of bill amount shall be paid after completion of work in all manner Re commissioning of solar plant. - The payment should be done as per actual work executed at site.

1. In case of discrepancy in amount in figure and words, amount mentioned in words will be considered final and binding.
2. **Bidder Shall Have to write "Quotation" mentioned name of work, name and address of agency/ contractor on sealed envelope.**
3. Bidder is required to quote each & every details otherwise quotation of such bidder shall not be considered.

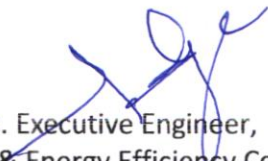
