1. Earthing Electrode supplied during the work must have warranty of minimum 5 year.
2. Bidder must provide all necessary test certificate report for all major material supplied.
3. After SETC Job bidder has to provide certificate for earth resistance value which is must be within permissible limit.
4. The defect liability of the work shall be one year from the date of handing over of entire system under contract to SMC.
5. Quantity mentioned here are approximate only. It may vary as per actual requirement.
6. SMC will not pay any transportation charges and also not provide any type of assistance which carrying out above mention work. All accessories needed in installation of above mentioned items are in bidder's scope only.
7. Bidders are instructed to visit the site locations and get acquainted with the nature of work before quoting this quotation. No dispute on later stage will be entertained. For any further query, bidder can contact Light department of South Zone-B (Kanakpur), SMC.
8. The rates should be inclusive of all taxes/duties/c.c./loading-unloading/ Labour including Transporting and excluding of GST.
9. Fulfillments of these conditions are must or else the quotation shall be liable for outright rejection.
10. Successful Contractor have to do Agreement, Surety & Undertaking on the non judicial stamp paper of Rs.300/- each purchased from Surat city only.
11. Successful Contractor shall deposit Security Deposit of 2.0 % of amount of Work order within 10 days from work order date. If Contractor fails to deposit same, penalty at 0.065% of SD amount per day will be levied.
12. Work Completion period will be 45 Days. If contractor fails to complete above work than penalty @ 0.2% of amount unexecuted work per day delayed should be recovered from your bill. Maximum delay penalty shall be recovered 10% of unexecuted amount of work order.
13. Payment shall be made as per actual measurement at site.
14. The rates will remain unaltered throughout the contract period.
15. It is to be clearly noted that advance planning must be done with the department before carrying out work at site.
16. Items which are not mentioned here but required to complete the work in all respect & as described in specification are in contractor's scope without any extra cost.
17. All required materials, tools, tackles and men power for the job shall be brought by the Contractor.

18. Payment shall be made after satisfactory Completion of whole SETC work in all respect and submission of required documents and invoice of the work.
19. All The Central, State and Local government rules and regulations including Safety shall be strictly followed by the Contractor.
20. The offer must be crafted neatly and easily readable. Erasing of words, overwriting or corrected words / figures will be rejected straight away.
21. In the event of any dispute / discrepancy / interpretation, the decision of engineer- in-charge (Executive Engineer) will be final and binding to the contractor.
22. Conditional offers or offer without EMD will be rejected straight away.
23. SMC shall be at liberty to terminate the contract any time during the contract period without giving prior notice to the contractor.
24. SMC will not be responsible to any accident / injury / death to/of the employee / manpower deployed by the contractor. No compensation shall be paid to contractor by SMC in such case(s)
25. The name of work i.e.“ Quotation for the work of” must be mentioned on the envelope. Without which quotation is likely to be rejected, which must be noted.
