Remittance of GST within stipulated period shall be the sole responsibility of the successful contractor/Tenderer, failing which SMC may recover the amount due, from any other payable dues with SMC and decision of Municipal Commissioner shall be final and binding on the contractor/ successful Tenderer in this regard. Further, the non-payment of GST to the government may lead to the termination of contract and forfeiture of security Deposit/Performance Guarantee Amount. If imposition of any other new taxes/Duties/levies/Cess or any other incidentals etc. or any increase in the existing taxes/Duties/Levies/Cess or any other incidentals etc. (Including GST) are imposed during the course of the contract, the same shall be borne by the successful contractor/Tenderer only; in no case SMC shall be liable for the same.

- (A) Scope of work:**
- (A.1) The scope of work of proposed work includes carrying out different types of wiring works (mostly SETC of point, fan, plug wiring, main line, wiring accessories, earthing etc.) at various aawas as and when required.
 - (A.2) The bidder shall have to offer his quote on % above / below / at par with respect to the prevailing R&B SOR 2026-27 (Electrical).
 - (A.3) The contract period of the proposed work shall be 01 (one) year or in limit of Rs.5,00,000/- (including GST) whichever is earlier.
 - (A.4) The rates once offered shall be fixed for the contract period including extension if any.
 - (A.5) Surat Municipal Corporation does not guarantee a particular amount of work during the contract period.
 - (A.6) The work shall be carried out strictly as per the norms and guidelines laid by the concerned departments of Central and state Governments as well as that by SMC.

- (B) General terms:**
- (B.1) **The offer must be submitted to: The Chief Accountant, Accounts Department, Surat Municipal Corporation, Tapi Bhavan, Tapipura, Surat. on or before Dt.19.09.2026.**
 - (B.2) **The mode of submission: RPAD or Speed Post of Govt. Postal Authority only**
 - (B.3) The agency shall fill the rates in this format only.
 - (B.4) This page filled with rates, and other details (Information regarding the bidder, PAN, GST copy, experience certificates/POs etc.) shall be sealed in a cover. Each page of this quotation must be stamped and signed by the sending agency.
 - (B.5) **Following details should be written on the sealed cover:** (1) Name of work (2) Address of the recipient (Chief Accountant, Accounts Department, Surat Municipal Corporation, Tapipura, Surat (3) Name and address of the sender (As actual) (4) Last date of submission of sealed quotation
 - (B.6) The successful agency shall have to submit a security deposit @ a rate of 2% of the order value amount within 15 days from the award of the work order. The DD / pay order shall be issued in favor of "Commissioner, Surat Municipal Corporation" and shall be payable at Surat only. A delay penalty at a rate of 0.065% of the SD value per day will be imposed for delayed days.
 - (B.7) The successful agency shall have to bind in contract with SMC. The agency shall have to submit three non judicial stamp papers each costing Rs.300/- for agreement, surety and undertaking respectively.
 - (B.8) Overall lowest quotation shall be considered.
 - (B.9) Payment: Payment shall be made on quarterly basis
 - (B.10) Deductions: All the payments and deductions shall be made as per prevailing rules and standard practice of SMC.
 - (B.11) The defect liability period for this work shall be 12 months
