

This specification covers the supply, installation, testing and commissioning of Tubelight fittings with necessary wiring in Rangila nagar Veg. market in D.T.P.S.40 in South East (Limbayat) Zone.

TRANSPORT, DELIVERY & STORAGE

The prices shall be F.O.R. site basis including packing & forwarding charges. The quoted price must include all the costs for necessary mode of transportation, delivery and storage of all material.

PAYMENT TERMS :-

Payment against workdone will be made as per following terms.

1. 100% of workdone amount will be paid on successful completion of job.

SECURITY DEPOSIT

Successful bidder shall deposite Security deposit shall be deposited at rate 2.5% of work order amount within 10 days from the date of work order. Failing which 0.065% of SD amount will be levied per day. This security deposit will be released after defect liability period, payment of final bill and clearance from audit department against capital work.

AGGREMENT

The successful contractor shall be required to enter into a contract agreement on suitable Gujarat stamp paper of Rs.300/- (Agreement, Undertaking and Surety for each) purchased from Surat (to be brought by contractor) on getting the order. This formality shall be completed within 10 days from the date of work order.

DEFECT LIABILITY PERIOD

The Bidder shall stand guarantee for the performance of entire system for 1 year.

DURING DFL PERIOD.

The Bidder must have to replace material in case of manufacturing defect, Electrical breakdown of material. BIdder must have to replace material within 48 hours after intimation by SMC.

Phisical damaged due to public nuiscance will not be cover in contractor's scope.

- 1. Rates quoted are inclusive of all taxes/duties, packing/forwarding, transportation, freight, watch & ward, insurance, construction cess etc. and excluding GST.
- 2. Price variation clause of any form shall not be accepted. Price shall remain firm till end of contract.
- 3. No correction, overwriting erasures in filling Quotation papers shall be considered unless countersigned.
- 4. In case of any misunderstanding due to interpretation of any terms, conditions or specifications the decision of Zonal Chief Shree & OSD, South East Zone, Surat Municipal Corporation, Surat shall be final and binding on the part of contractor.
- 5. The correctness of details given in tender documents is not guaranteed. The contractor shall independently obtain all necessary information for making the Quotation. The contractor shall be deemed to have examined the contract documents, to have generally obtained his own information in all matters that might affect the tendered rates.
- 6. Bidder has to follow all the rules and regulations of safety.
- 7. The contract shall be constituted according to and subject to laws in India and State of Gujarat and under the jurisdiction of courts of Gujarat at Surat only.
- 8. Bidder must have to keep & maintain all the necessary tools & equipment for safety as per government rules.
- 9. All equipment/material/accessories are to be supplied by contractor. No transportation will be provided by the Corporation.
- 10. Any damage to material during transportation shall be to contractor's account.
- 11. Quotation documents are not transferable.
- 12. Corporation will not defray expenses incurred by Bidder in Quotation.
- 13. Conditional Quotation shall not be accepted.

INSURANCE :-

- 14. Contractor shall be responsible, at his own expenses for confirming to and complying with all existing laws and regulations to protect his personnel against job connected accidents and third party claim against property damage as well as for the death and injury arising out of any action on the part of the contractor personnel while engaged in the performance of duties in connection with the contract. The contractor shall furnish the corporation with documentation certifying that he has procured and Maintenance coverage to this extent as follows:
- 15. Workman's Compensation Insurance (Including) occupational disease covering the contractor's personnel engaged on the project/job.
- 16. General liability insurance (including contractual) for third party injuries, including accidental death to any person and property damage.
- 17. The documentation to be furnished to the Surat Municipal Corporation within 10 days of signing of the contract. Contractor will be responsible for insurance cover of his personnel and corporation will have no liability whatsoever on this account.
- 18. CONTRACT LABOUR (Regulation & Abolition) Act 1970:-
- 19. As per the labour act 1970, you are requested to take the labour license from the concern Government authority. If you will start the work without the labour license, you will only be held responsible for any situation arising than after. You are entirely responsible for labour regulations as per prevailing labour laws & other statutory requirement like provident fund, gratuity, child labour etc.
- 20. TERMINATION FOR UNSATISFACTORY PERFORMANCE:-
- 21. If the corporation considers that the performance of the contractor is unsatisfactory or not up to the expected standard, the corporation shall notify the contractor in writing and specify in detail the cause of dissatisfaction. The corporation shall have the option to apply reasonable penalty and recovery OR to handover this work to other agencies at the cost and risk of the contractor and terminate this contract if the contractor fails to comply with the requisition contained in the said written notice issued by the corporation to the contractor within 10 (Ten) days of the receipt thereof.
- 22. Right to accept any or to reject any or all tenders without assigning any reason thereof is reserved by the competent authority of corporation.
- 23. Any other details if required can be had from the office of the Executive Engineer, South East Zone, Surat Municipal Corporation on request and prior to submitting the tender. No dispute at a later date shall be entertained.
- 24. The competent authority of Surat Municipal Corporation reserves the right to reduce the scope of work and split the tender in two parts or more without assigning any reason even after award of contract.
- 25. The work shall be carried out during working days between 8.30 A.M. to 6.00 P.M. only. If the Contractor intends to work on Holidays or Outside working hours specified, he shall take prior written permission from Engineer-in-charge.

- 26. It will not be possible to provide any housing accommodation at site to the erection staff of the bidder. Further labours, welding sets and sundry materials like cotton/chindi waste, tools, spanners, packing etc. required for the erection shall not be supplied by the Corporation.
- 27. The contractor should give their rates on SURAT SITE delivery basis i.e. the rates offered must include packing forwarding, insurance, and transportation up to the sites, including loading/unloading, Watch & Ward etc. The rate should also EXCLUDE GST and including of all other taxes like sales tax, works contract tax, labor tax, excise duty & any other taxes/levies, construction cess.
- 28. It should be clearly mentioned in the tender regarding the prices, exact delivery period, percentage of taxes/duties included and other terms of business. The Corporation shall not supply any sales-tax declaration form. The exact percentage of taxes/duties included should be specified.
- 29. SMC reserves the right to purchase the materials only as per its minimum and urgent requirement out of the materials mentioned in the price list.
- 30. Any dispute arising out of the contract shall be subjected to "SURAT JURISDICTION."
- 31. Acceptance of tender will rest with competent authority who does not bind himself to accept the lowest tender and reserves the right to split the work among Bidders, reject any or all tenders and no reasons will be given for acceptance or rejection thereof. The Quatation whose bidder is accepted should enter into regular contract agreement and abides by all rules and regulations embodied in the tender. THE FOLLOWING MUST BE CONSIDERD:
- 1. Each tender must accompany with latest passport size photograph along with specimen signature of the bidder(s).
- 2. The Corporation shall not be responsible for any accident or damage done to the workman/ staff of the Contractor.
- 3. The Contractor shall observe Government Rules regarding labours, insurance, etc., and obtain labour license etc.
- 4. No facilities will be given to the contractor at work-site by SMC in any type or in any manner.
- 5. The contractor has to carry out the work with his own tools/tackles/equipment/instruments/ ladders etc.
- 6. Material/equipment storage facility at work-site will not be provided by SMC to the contractor.
- 7. It is presumed that, the bidder has seen the work-site and the nature of work before quoting the rates into the tender.
- 8. The price quoted in the tender shall be inclusive of all types of taxes, levies, duties, transportation, labour, CC etc.
- 9. Any loss, damage to SMC property due to the carelessness of the contractor in work, all will be deducted from contractor's bill.
- 10. In case of any dispute arising out of this tender work, the decision of SMC will be final and will be accepted to the contractor.
- 11. All the safety precaution, necessary arrangement, colour code, notice board, etc., as per Govt. safety rules
- 12. In the event of the tender being submitted by a partnership firm it must be signed separately by all partners with their latest photographs duly signed thereof. The partnership deed must also be attached with the tender.
- 13. The bidder(s) shall have to attach sales tax certificates with residential address evidences. (if applicable)
- 14. For bidder(s) paying royalties to the Government, the receipt of the same must be produced.
- 15. All the applicant contractors are required to have their own employers' code numbers under EPF Act., and are required to comply the applicable provisions of said stature regularly and totally.
- 16. Further the contractors for services are required to produce the certified copies of paid challans in respect of employees/workers employed by said contractors in respect of work allotted by Surat Municipal Corporation, along with copies of Pay Roll and Muster Roll. If the same are not produced, the bill will not be released.
- 17. The successful bidder(s) shall be required to submit photographs, address and specimen signatures in duplicate at the time of executing the agreement. The agreement shall be executed by partner/person who have signed the tender/ quotation.
- 18. The competent authority of Surat Municipal Corporation reserves the right to reduce the scope of work and split the tender in two parts or more without assigning any reason even after award of contract.
- 19. The work shall be completed within 30 days (Thirty days) and it will start after 10 Days from the date of Work order. The work must be completed in all respect within stipulated time period as mentioned in Important instruction to bidder, failing which penalty @ 0.2% of order value per day of delay subject to maximum 10% of order value shall be charged and shall be deducted from the bill or any outstanding payment. Also, if contractor fails to execute the work than action against contractor will be taken as per decision of competent authority of SMC and that should be bind to contractor.
- 20. Quantity of each value may vary as per actual site requirement. Successful bidder must take actual quantity before execution of work. Payment should be made as per actual measurement at site.
