Terms/conditions of quotation

6. Successful Bidder must have to submit Security Deposit (SD) of amounting 2% of quoted amount, with the offer in form of Cheque/DD/Pay order only and same will be released after satisfactorily completion of work.
7. Successful bidder shall have to submit contract agreement, undertaking and surety on Stamp paper of Rs.300/- each within 10 days of work order date, as per SMC guidelines.
8. Rates must be filled in this quotation paper only and returned duly sealed & signed.
