- ➤ Defect liability period shall be One year from the commissioning of the Submersible pump at site.
- All employees deployed for the said work shall be provided with personal safety equipments & accessories. Contractor shall be responsible to the accident/injury/Loss to any of the staff members of them.

TIME LIMIT / WORK COMPLETION PERIOD:-

➤ Time limit of the work is 15 days from the issue of work order date. If the contractor fails to complete the work within the stipulated completion date for the work or he shall pay work delay penalty 0.20% of contract value per day of delay in completion or part thereof as the case may however, be subjected to a maximum of ten (10) percent of the contract value.

SECURITY DEPOSIT/AGREEMTNT/STAMP DUTY:-

- Successful Contractor shall be required to deposit an amount equal to 2.5% of total order value as Security Deposit in Cash/ by Demand Draft within 10 (Ten) days from date of work order, otherwise penalty @ 0.065% of the Security deposit Amount per day of delay shall be charged.
- Successful contractor shall also be required to enter into contract agreement on Gujarat Stamp Paper purchased from Surat worth Rs.300.00 (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.
