SCOPE OF WORK, TERMS & CONDITION :-

- Tenderer shall have to Supply, Erection, Testing & Commissioning of 0.5 HP & 1.0 HP Single phase Mono Block Pump at Sarothana Nature Park of New East(Sarothana)Zone-B.
- Scope of work includes Supply, Erection, Testing & Commissioning of Mono Block Pump with related miscellaneous Works.
- Material/Supply shall be free from any defect and as per vendor list.
- Contractor shall directly follow the instructions by the SMC representative/ authorized

personal from concerned department at the site.

- Defect liability period shall be One year from the commissioning of the Submersible pump at site.
- All employees deployed for the said work shall be provided with personal safety equipments & accessories. Contractor shall be responsible to the accident/injury/Loss to any of the staff members of them.
- Contractor shall follow all applicable laws, rules, regulation for such type of work.
- Quotation once offered shall not be withdrawn.
- Quoted rates shall be valid for 120 days from the date of opening of quotation.
- Quotation once accepted shall be binding to the contractor.
- The Rate should be all duties/ taxes, Transportation material & labour cost. all duties/ taxes levied by S.M.C. or any Govt. Department shall be payable by the contractor.
- Right to accept any or to reject any or all the quotation without assigning any reason thereof is reserved by the competent authority of Surat Municipal Corporation, Surat.
- The decision of Divisional head of New East (Sarhana) Zone - B will be final in respect of disputes what so ever arise.
- In absence of EMD, the Quotations will be Liable to be rejected.
- Quantity of items may be actually reduced or increased during actual execution of work, contractor shall carry out the work accordingly.
- The contract shall be constituted according to and subject to laws in India and state of Gujarat and under the jurisdiction of courts of Gujarat at Surat City only.

TIME LIMIT / WORK COMPLETION PERIOD:-

- Time limit of the work is 15 days from the issue of work order date. If the contractor fails to complete the work within the stipulated completion date for the work or he shall pay work delay penalty 0.20% of contract value per day of delay in completion or part thereof as the case may however, be subjected to a maximum of ten (10) percent of the contract value.

SECURITY DEPOSIT/AGREEMENT/STAMP DUTY:-

- Successful Contractor shall be required to deposit an amount equal to **2.5% of total order value as Security Deposit** in Cash/ by Demand Draft within 10 (Ten) days from date of work order, otherwise penalty @ 0.065% of the Security deposit Amount per day of delay shall be charged.
- Successful contractor shall also be required to enter into contract agreement on Gujarat Stamp Paper purchased from Surat worth Rs.300.00 (to be brought from Surat by the contractor) on getting the order. However, the stamp duty at prevailing rate shall be applicable if revised by Government.

PRICES AND TERMS OF PAYMENTS: -

- **All rates should be quoted excluding GST.**
- Contractor must understand clearly that the prices quoted are for the total works i.e. include all Material/Spares, labour, supervisions, transportation, loading, unloading, watch and ward etc. excluding GST. No claim for additional payment beyond the prices quoted will be entertained and contractor will not be entitled subsequently to make any claim on any ground.
- No payment shall be made in advance.
- Payment shall be released after completion of said work.
