- (b) States that the said scheme shall be kept open to inspection by the public at the office of the Surat Municipal Corporation, Surat during office hours on all working days except Sundays and hodidays and (c) fixes 4-3 1989 as the date for the purpose of

clause (b) of sub-section (2) of the said Section 65.
