In exercise of the powers conferred by section 50 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act") sanctioned a draft Town Planning scheme Udhina No.2 (hereinafter referred to as "the said draft scheme") submitted it by Surat Urban Development Authority;

AND WHEREAS in exercise of the powers conferred by section 50 of the said Act, Government of Gujarat had appointed the Town Planning officer for the said draft scheme;

AND WHEREAS the Town Planning officer so appointed has submitted to the Government of Gujarat the Town Planning scheme, Udhina No.2 Preliminary scheme (hereinafter referred to as "the said Preliminary scheme") as required under sub-section (2) of section 52 and section 64 of the Gujarat Town Planning and Urban Development Act, (President's Act No. 27 of 1976);

NOW THEREFORE, in exercise of the powers conferred by section 65 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) the Government of Gujarat hereby:

- (a) sanctions the "said preliminary scheme" subject to the modifications enumerated in the schedule -

(b) states that the said scheme shall be kept open to inspection by the public at the office of the Surat Municipal Corporation, Surat during normal business hours except on
