WHEREAS under Government Notification, No. GH/V/269
Housing and Urban Development Department No. GH/V/269
of 82 /IPS-1479-2747(82)L dated 3rd June, 1982, the
Government of Gujarat had in exercise of the powers
conferred by sub-section(2) of section 48 of the Gujarat
Town Planning and Urban Development Act, 1976 (President's
's Act No. 27 of 1976) (hereinafter referred to as "the
said Act") sanctioned a draft Town Planning scheme
Udhna No.2 (hereinafter referred to as "the said draft
scheme") submitted to by Surat Urban Development
Authority ;
AND WHEREAS in exercise of the powers conferred by
section 50 of the said Act, Government of Gujarat had
appointed the Town Planning officer for the said
draft scheme;
AND WHEREAS the Town Planning officer so appointed has
submitted to the Government of Gujarat the Town Plan-
-ing scheme, Udhna No.2 Preliminary scheme (hereinafter
referred to as "the said Preliminary scheme") as
required under sub-section(2) of section 52 and section
64 of the Gujarat Town Planning and Urban Development
Act, (President's Act No. 27 of 1976) ;
NOW THEREFORE, in exercise of the powers conferred by
section 55 of the Gujarat Town Planning and Urban
Development Act, 1976 (President's Act No. 27 of 1976)
the Government of Gujarat hereby:-
(a) sanctions the said preliminary scheme " subject
to the modifications enumerated in the schedule -
...p.t.o...

(b) states that the said scheme shall be kept open to inspection by the public in the office of the Surat Municipal Corporation, Surat during office hours, and shall be kept open except on days when the Corporation is closed.

(c) fixes 18 -

(b) of sub-section (2) of the said Section 55.

1. The Development Control Regulations shall be treated as excluded from the preliminary scheme documents.
