The Gujarat Town Planning and Urban Development Act 1976 NO.GH/V/ 70 of 1998/TPS/1491/2769/L:WHEREAS under Section 41 of the Gujarat Town
Planning and Urban Development Act,1976
(President's Act No.27 of 1976) (percinafter
referred to as "the said Act") the Surat
Urban Development Authority declared its
intention of making of the Town Planning
Scheme No.2-Vesu-Bharthana-Vesu (SUDA);

AND WHEREAS under Sub-Section(1)of
Section 42 of the said Act, the Surat Urban
Development Authority (hereinafter called
the "said Authority") made and published
