WHEREAS under Section 41 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act") the Surat Urban Development Authority declared its intention of making of the Town Planning Scheme No.2-Vesu-Bharthana-Vesu (SUDA);

AND WHEREAS under Sub-Section(1) of Section 42 of the said Act, the Surat Urban Development Authority (hereinafter called the "said Authority") made and published duly in the prescribed manner a draft scheme (hereinafter called "the said scheme") in respect of the area included in the Town Planning Scheme No.2-Vesu-Bharthana-Vesu (SUDA);

AND WHEREAS after taking into consideration the objections received by it the said Authority submitted the said scheme to the State Government for sanction under Section 48 of the said Act in the manner provided therein;

NOW, THEREFORE, in exercise of the powers conferred by sub-section(2) of Section 48 of the said Act, Government of Gujarat, hereby:-

- (a) sanctions the said scheme and
- (b) states that the said schemes shall be kept open to the inspection of the public at the
