NO.GH|V| 110 of 1997|TPS-1496-804-L:- WHEREAS under Government Notification, Urban Development and Urban Housing Department No.GH|V|143 of 1983-TPS-1480-1958-(83)-L dated the 29-6-1983 the Government of Gujarat had, in exercise of the powers conferred, by sub-section (2) of section 48 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) (hereinafter referred to as "the said Act") sanctioned the draft Town Planning Scheme, Surat No.3 Karanj (hereinafter referred to as "the said draft scheme") submitted to it by the Surat Urban Development Authority;

AND WHEREAS in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for the said draft scheme;

AND WHEREAS under Government Notification, Urban Development and Urban Housing Department NO.GH|V| 138 of 1993|TPS-1491-1614-L dated 14-7-1993 the Government of Gujarat in exercise of the powers conferred by section 65 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No.27 of 1976) has sanctioned the Town Planning Scheme, Surat No.3 (Karanj) - Preliminary;

AND WHEREAS the Town Planning Officer has submitted to the Government of Gujarat, the Town Planning Scheme, Surat No.3 -Karanj -Final Scheme (hereinafter referred to as "the said final scheme") as required under sub-section (2) of section 52 and sub-section (2) of section 62 of the said Act;



- (c) fixes the 10th day of October, 1997 as the date for the purpose of clause (b) of sub-section (2) of the said section 65.
