Act, 1976.

No.GH/P/211 of 1980/TPS-1480/4267-L :- WHEREAS under
Government's notification, Panchayats and Health -
Department, No.GH/P/1237/TPS-4267/573-P, dt.19-4-1980,
the Government of Gujarat, was in exercise of the
powers conferred by sub-section (2) of section 26 of
the Bombay Town Planning Act, 1954 (Act No.XXVII of
1954) (hereinafter referred to as 'the old act')
sanctioned a draft Town Planning Scheme, Surat No.4
(Ashwanikumar-Navagam) (hereinafter referred to as
"the said draft scheme") submitted to it by Surat
Municipal Corporation;

AND WHEREAS in exercise of the powers
conferred by section 31 of the Old Act, Government of
Gujarat had appointed the Town Planning Officer for
the said draft scheme;

* AND WHEREAS the Town Planning Officer so
appointed has submitted to the Government of Gujarat
the Town Planning Scheme Surat No.4 (Ashwanikumar-
Navagam) Preliminary Scheme - (hereinafter referred to
as "the said preliminary scheme") as required -
under section 64 of the Gujarat Town Planning and
Urban Development Act, 1976 (President's Act No.27 of
1976);

Now, THEREFORE, in exercise of the powers
conferred by section 65 of the Gujarat Town Planning
and Urban Development Act, 1976 (President's Act No.-
27 of 1976) the Government of Gujarat hereby:-

- sanctions the said "preliminary scheme" subject to the modifications enumerated in the schedule - appended hereto;
- States that the said scheme shall be kept open to inspection by the public at the office of the - Surat Municipal Corporation, Surat during office hours on every day except Sundays and Holidays; and
- fixes the 27th day of January, 1981 as the date for purpose of clause (b) of sub-section (2) of the said section 65.

SCHEDULE

Development control Regulations shall be treated as
excluded from the Preliminary scheme documents.
