## HOTIFICATION .

The Gujarat No.GH/P/74 of 1982, TPS-1481-1499-(82)L: WHEREAS Town Planning under Covernment Notification, Panchayats and and Urban Health Department, No. GH/P/ 1237, TPS-4267/573/P, Development dated 19.4.1968, the Government of Gujarat, had in exercise of the powers conferred by subsection (2) of section 28 of the Bombay Town Planning Act, 1954 (Bon. Act No. XXVII of 1955) (hereinafter referred to as the "the old act") sanctioned a draft Town Planning Scheme, Surat No. 4(Ashwani-Kumar-Navagam) (hereinafter referred to as "the said draft scheme") submitted to it by Surat Municipal Corporation.

> AND WHEREAS in exercise of the powers conferred by section 31 of the Old Act, Government of Gujarat had, appointed the Town Planning Officer for the said drait scheme.

AND WHEREAS under Government Notification Thichayats, Housing and Imban Development Dent's ... 01/14 211 of 1980/ TPS-1480-4207-L, dated 1 th December 1980 the Government of Cujarat had, in exercise of the powers conferred by section 65 of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act, No.27 of 1976) (hereinafter referred to as the said New Act) sanctioned the Town Planning Scheme Surat No. 4 (Ashwani Kumar Navagam) preliminary;

AND WHEREAS the Town Planning Officer has submitted to the Government of Gujarat the Town Planning Scheme Surat No.4 (Ashwanikumar-Navagam) Final scheme (hereinafter referred to as "the said Final scheme") as required under sub-section (2) of section 52 and sub-section (2) section 62 of the said New Act;

NOW, THEREFORE, inexercise of the powers conferred by section 65 of the said New Act, the Government of Gujarat hereby:-

- (a) sanctions the said "Final scheme" subject to the modification enumerated in the schedule appended hereto;
- (b) states that the said scheme shall be kept open to inspectionby the public at the office of the Surat Municipal Corporation, Swat during office hours on every days except Sundays and Holidays; and
- (c) fixes the 21st day of June, 1982 as the date for purposes of clause (b) of subsection (2)of the said section 65.
