- 2-In the preabble of Regulations Constrailing the Dovelopment of the area under the Town Flanning scheme the lest line "the provisions of the under mentioned regulations shall prevail" shall be read as "the provisions of Regulations of the Development plan of Surat Urban Development Authority shall prevail".
- 3-The percentage of land deductions of the Government lands shell be made at per with the other lands by the Town Planning Officer appointed to finalise the scheme.
