The Gujarat
Town Planning
and Urban

Act No. 976

No. GH/P/99 of 1981/TPS-1400/1031/(01)-L:- WHEREAS
Under Government Notification, Panchayats and
Health Department No. GH/P/1239/TPS/4267/572 dated
20th April, 1968, the Government of Gujarat
had, in exercise of the powers conferred by sub-
section (2) of section 23 of the Bombay Town
Planning Act, 1954 (Bom. Act No. XXVII of 1955)
(hereinafter referred to as "the old Act")
sanctioned a draft Town Planning Scheme Surat
No. 7 (Anjana) (hereinafter referred to as "the
said draft scheme" submitted to it by Surat
Municipal Corporation.

AND WHEREAS in exercise of the powers
conferred by section 31 of the old Act Government
of Gujarat had appointed the Town Planning
Officer for the said draft scheme.

AND WHEREAS the Town Planning Officer so
appointed has submitted to the Government of
Gujarat the Town Planning Scheme Surat No. 7
(Anjana) Preliminary scheme (hereinafter referred
to as "the said preliminary scheme") as required
under section 64 of the Gujarat Town Planning and
Urban Development Act, 1976 (president's Act
No. 27 of 1976).

NOW, THEREFORE, in exercise of the powers
conferred by section 65 of the Gujarat Town
Planning and Urban Development Act, 1976
(president's Act No. 27 of 1976) the Government
of Gujarat hereby :-

- (a) sanctions the said "preliminary scheme"
subject to the modifications enumerated
in the schedule appended hereto.
- (b) States that the said scheme shall be kept
open to inspection by the public at the
office of the Surat Municipal Corporation
Surat during office hours on every day
except Sundays and Holidays and
- (c) fixes the 10th day of August, 1981 as
date for purposes of clause (b) of sub-
section (2) of the said section 65.

S C H E D U L E

Development Control Regulations shall be
treated as excluded from the preliminary
scheme documents.

2. In the re-distribution statement of Town
Planning Scheme Surat No. 7 (Anjana)
(preliminary scheme) original plot area of
original plot of original plot 42/10 and
the final plot area of Final Plot 74 at
S.No. 79(7) of the Re-distribution statement



shall be read as 1780 sq.mt. and 1693 sq.mt. respectively in lieu of the one shown in the redistribution statement of the preliminary scheme submitted by the Town Planning Officer, (Appendix No.1).

3. The eastern boundary of original plot 42/10 as shown in plan No.2 and plan No.3 of the preliminary scheme is modified as shown in yellow in part-plan No.2 (Appendix No.2) and part-plan No.3 (Appendix No.3) of the preliminary scheme as modified as shown in yellow in part-plan No.2 (Appendix No.2) and part-plan No.3 (Appendix No.3) of the preliminary scheme.

4. The eastern boundary of final plot 74 as shown in plan No.3 and plan No.4 of the preliminary scheme is modified as shown in blue in part-plan No.3 (Appendix No.3) and part-plan No.4 (Appendix No.4) of the preliminary scheme.
