NOTIFICATION

The Bay Town lanning Act 195% No.G.B/P/1678/TPS/4269/5329/P:-Whereas the T.P. Scheme, Surat No.VIII (Umarwada) made by the Collector, Surat, Dist. Surat under Sub Section (2) of section 23 of the Bombay Hown Planning Act, 1954 in respect of the area included in the said Scheme has been sanctioned by the Government of Gujrat under section 26 of the Bombay Town Planning Act 1954 (Bom XXVII of 1955) (hereinafter referred to as the said Act) by Government Notification Panchayat and Health Department No.GH/P/1258/T.P.S./4267/671/P dated 10th May 1968.

And Whereas on the application of the Surat Municipal Corporation the Town Planning Officer, Town Planning Scheme No.VIII (Umarwada) has prepared a preliminary Scheme Surat No.VIII, having regard to the provisions of Section 45 of the Act.

And Whereas in pursuance of the provisions of Sub-Section (1) of Section 46 of the said Act, the said Corporation made an application on 27th June 1969, to the Government of Gujarat through the said Town Planning Officer, to vest in it the lands described in the schedule hereto annexed and shown in the plan of the said preliminary Scheme, for the purpose of undertaking works specified in Sec 45 of the said Act and referred to in the said Schedule.

And Whereas the Government of Gujarat is satisfied that it is urgently necessary in the public interest to empower the said Corporation to enter into the said lands for the purpose of executing the said works.

Now therefore in exercise of the powers conferred by Sub-Sec (2) of Section 46 of the Bombay Town Planning Act 1954 (Bom XVII of 1955) the Government of Gujarat hereby directs the Town Planning Officer, Town Planning Scheme No.VIII to take the possession of the lands, described in the said Schedule and further directs the said Corporation to complete the execution of the works relating to roads and to the open space mentioned in item No.(A) and (B) of the said schedule within six months and the execution of the works relating to market mentioned in item (C) of the said schedule within ax two years from the date of the taking possession of the respective lands.
